Citizen Concerns: Manternach advised she received numerous complaints over the month regarding a Pit Bull running loose on at least 5 different occasions. Manternach advised one occasion, she brought the Pit Bull down to City Hall and followed up with the Sheriff Department, Sue Burger caught the Pit Bull another time, and on another occasion, the Pit Bull was dropped at Manternach's personal residence. Manternach advised proper documentation has been forwarded to the attorney and follow up steps are being taken.

Motion by Smock, seconded by Lueck to set wage for backup lawn mower to \$13/hr.

Ayes: all, carried. Council reviewed proposed budgeted numbers and made changes as necessary to make funds balance. Council agreed in not raising property taxes and keeping the general tax levy at \$7.94. Manternach advised these numbers will be entered in the state budget form and presented to the council on 02/15 with a public hearing to follow on 03/15. Council discussed providing Veterans Day as a holiday for employees who have served. Motion by Smock, seconded by Leuchs to approve Veterans Day as a paid holiday to employees who have served.
