THE PROGRAM PROVIDES A VARIETY OF SERVICES SUCH AS CASE MANAGEMENT, EMERGENCY RENTAL AND UTILITY ASSISTANCE, DISTRIBUTION OF FOOD AND CLOTHING, TRANSPORTATION, FINANCIAL EDUCATION, REFERRALS AND OTHER SERVICES THAT PROMOTE SELF-SUFFICIENCY AND ECONOMIC STABILIZATION.
