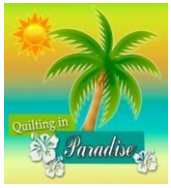

LABELS: USE SAFETY PINS ONLY!

Make two labels by writing your entry number (received via email) on a piece of white/off-white fabric about the size of an index card in black permanent ink Use at least two safety pins to pin one of the labels directly to the quilt back in the lower left corner. That's all the information we allow the judges to see. If the quilt has another label that identifies the maker(s), this label must be covered.

Pin the second label (again using at least two safety pins) to the pillowcase or quilt bag near the center of the opening of the quilt bag.

When you fold and pack your quilt into the pillowcase, fold it so the label with the entry number can be easily seen by the volunteers when they turn back the pillowcase to double check the entry numbers.
