Boating Safety/Ethics – April is a busy month on Toledo Bend, and there will be many anglers on the water competing for a spot to catch a nice bass or a box full of crappie. Regardless of the immense size of the Lake, there are enough anglers to result in crowded conditions in certain areas from time to time. When this occurs, we should be mindful that we are fishing public water and that we should not expect to have it to ourselves.

Regrettably, conflicts do occasionally arise, and the possibility of hurt feelings, or worse, does exist. This situation is not unique to Toledo Bend, it is at least a state-wide concern, so much so that the Louisiana Legislature has seen fit to enact legislation to address such incidents.

A June 2017 Press Release from the Louisiana Department of Wildlife & Fisheries provided information on a case made by local Agents on Toledo Bend which resulted in the issuance of a citation for harassment of persons lawfully fishing. The Press Release stated, "*Harassment of persons lawfully fishing brings a up to a \$750 fine and 90 days in jail. The harassment of persons lawfully fishing regulation provides that it is unlawful to disturb any hunter, trapper, or fisherman who is engaged in the lawful taking of a wild animal or who is engaged in the process of taking, with intent to dissuade or otherwise prevent the taking, or to prevent such person's enjoyment of the outdoors.*"

Common courtesy and old-fashioned manners should be enough to prevent such citations being issued. Anglers and boaters are urged to respect one another while afloat as well as at all other times.

Sabine Parish Aquatic Education Clinic-For several years TBLA has partnered with Louisiana Department of Wildlife & Fisheries (LDWF) to conduct a three-day Aquatic Education Clinic at Cypress Bend Park. During the clinic, all fifth-grade students in Sabine Parish will be bused to the park site where they will receive instruction on fish identification, boating safety, bait casting, fisheries biology and ethical conduct. Each student will also be given the opportunity to fish with cane poles.

This is an excellent program that exposes children to the sport of fishing, with many of the children catching their first fish during the event. This program serves as a gateway not only to fishing but many other outdoor activities and may well be the first chance some of the participants have to learn about fishing and boating.

Tim Dean has been TBLA's Coordinator for this program in recent years. Tim has done an excellent job but will be passing the torch to Tammy Mong following this year's event. The event requires quite a few volunteers to make it successful and more help is always welcomed. Toledo Bend Lunker Bass Program

Sean Kinnon of DeQuincy, LA caught a 14-pound Lunker and weighed it in during the Fort Polk Bassmaster Open Tournament on March 2, 2019. Sean’s fish is Lunker number 25 of the season.

Chance Vicknair of Hemphill, TX caught a bass weighing 10.43 pounds on March 8, 2019. Chance’s fish was previously tagged as a Lunker. The fish was weighed in at Fin and Feather Resort and is Lunker number 26 for the current year.

On March 8, 2019, Cody Pitt of Many, LA weighed in a 10.52-pound bass at Fin and Feather Resort that upped the Lunker total to 27. This is Cody’s second Lunker of the year. He also caught a fish weighing 11.49 in January!

Lunker number 28 was caught by Tyler Wilkerson of Negreet, LA on March 8, 2019. Tyler’s fish tipped the scales at 10.53 pounds and was weighed in at Buckeye Landing.

David Burton of DeRidder, LA weighed in Lunker number 29 of the season at Buckeye Landing on March 9, 2019. David’s fish weighed 10.01 pounds.

On March 13, 2019, Bryan Hargiss of St. Louis, MO caught a fish weighing 11.14 pounds and weighed it in at Toledo Town and Tackle. Bryan’s fish is Lunker number 30 for the season.

Darren Burns of Lake Charles, LA brought in a 10.27 pound fish on March 20, 2019 and weighed in at Fin and Feather Resort. Darren’s fish is Lunker number 31 of the season.

Lunker number 32 was caught by Robert Prejean of Sulphur, LA on March 20, 2019. This 10.02 pound fish was weighed in at Fin and Feather Resort.

Fin and Feather Resort weighed Aaron Ray’s 10.26 pound Lunker number 33. Aaron Ray is from Princeton, LA.

On March 20, 2019, Richard Gautreaux of Gonzales, LA weighed in Lunker number 34, tipping the Holly Park Marina scales at 10.07 pounds.

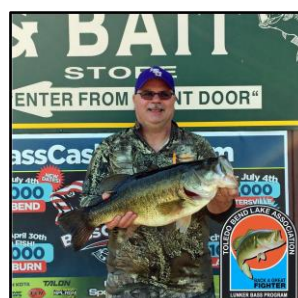
