**ORDER GRANTING STIPULATED

18 The Court, having considered the Parties' Stipulated Motion for Leave to Depose
19 Incarcerated Person Yomtov Scott Menaged, and good cause appearing,

20 **IT IS HEREBY ORDERED:**

21 1. Mr. Menaged shall appear for the deposition requested by the Parties on dates
22 of the Parties' choosing at the FCI La Tuna facility in Anthony, Texas. The Parties will work
23 cooperatively with one another and the FCI La Tuna facility staff to select the dates for Mr.
24 Menaged's deposition. Given Mr. Menaged's substantial knowledge of the relevant facts of
25 this case, the Parties agree that the deposition may be accomplished in 12 hours total over
26 two consecutive days. The deposition shall begin on each day at 9:00 a.m., and Mr. Menaged

1 shall be afforded breaks at least every hour. The Parties will provide notice to Mr. Menaged
2 of the deposition dates selected at least two weeks prior to the first day of the deposition.

3 2. All other Rules of Civil Procedure regarding depositions and related discovery
4 shall apply.

5 3. Nothing in this Order shall be construed as limiting or interfering with the FCI
6 La Tuna facility's rules and regulations for taking depositions of incarcerated persons.
7 Specifically, the Parties shall comply with guidance issued by the Bureau of Prisons
8 regarding the taking of depositions of inmates, as explained in the Legal Resource Guide to
9 the Federal Bureau of Prisons, and all other directions of FCI La Tuna staff.
