The Fire Danger Level is currently at Level 4, VERY HIGH. Stage 1 fire restrictions are expected to go into effect on August 3, 2024. Montana Fish, Wildlife and Parks, <u>www.fwp.mt.gov</u> explains Stage 1 and Stage 2 restrictions and closures. This community has been very proactive preparing homes and property for a wildfire event. Now, it's time to prepare your family to be **Ready** should the need arise.

If a wildfire threatens our community and evacuation becomes necessary, an emergency text and emails will be sent from the Big Mountain Community website to those who have registered. If you are not registered, go to <u>www.bigmountaincommunity.com</u> click on **"register"** in the top right corner of the page and enter your cell phone number and email address

It is important that you and your family members review and are familiar with the **Big Mountain Fire District Evacuation Plan.** If you are unfamiliar with the plan, it is located on the Big Mountain Community website. The plan outlines each level of evacuation in detail, however, keep in mind that in some cases there is **no time** to follow a formal notification plan. Fire behavior can change rapidly with changing conditions and progress to an imminent threat that calls for an immediate full-scale evacuation. Communication could be difficult, intermittent, or impossible. There could be a loss of power. A battery-operated radio, with extra batteries, is recommended to monitor local radio stations for changing wildfire progression.

It is also important that your family have a **wildfire action plan**. Decide on a designated meeting place should you become separated. Consider evacuation of family pets and their needs. Assemble **To Go Bags** for family members and pets. Gather important documents, photographs, identification, medication, etc. for an easy grab and go. Once again, the Big Mountain Community website is an excellent resource for brochures and checklist to help you prepare for an evacuation. If you feel threatened, do not wait to leave, **GO**!

The BMFD Firewise encourages the adage, "when in doubt, get out."

The **Shelter in Place Wildfire Evacuation Drill** was last Tuesday evening. A text message was sent at 6:30 pm to evacuate and gather at the Birch parking lot. Emails were sent as the group changed locations. There was a briefing at each location with the opportunity to discuss and ask questions. It was a valuable exercise and hopefully people are more comfortable with

sheltering in place.
