 - Company providing pond services has provided a stormwater maintenance contact. Steve also talked with Public Works to determine responsibility of stormwater system maintenance and the County put a work order into their system for and assessment of the Canterbuty system.
 - Lowery's recommended the trees at the front entrance be trimmed and Board had noticed that they might need work as well. Work will be performed by Lowery's landscaping.
