- 1. Meeting called to order and roll call. Mayor Wallace called the Regular Meeting of the Board of Trustees to order. Clerk Ray called roll and declared a quorum. Agenda was posted at the Calumet Town Hall on Wednesday March 3, 2020 @ 12:00 p.m.
- 2. Consider approval or amendment of minutes for the Regular Meeting held February 4, 2021, with action as necessary. Trustee Snow made a motion to approve the minutes for the Regular meeting held February 4, 2021 with adding to item #12 agenda A. with No Action, and scratch Margaret Stratton, Treasurer as present for meeting. Mayor Wallace declared the motion carried.

Trustee Snow asked Terry Brungardt if the fire department was going to hold the Easter egg hunt this year for the children.
