Brothers,

I wanted to explain the reasoning for my by-law change regarding the name change for the International *Association* Legions of Honor.

During the 2023 - 2024 term of office for Past International Commander Russ Gray, we filed the appropriate forms for our taxes. Upon following up we found out that the filing was revoked. Upon investigation it was found out that the appropriate tax forms had not been filed from 2008 - 2022, and the EIN or Employer Identification Number which is used for tax filing and reporting purposes was revoked on September 15, 2011 after the first 3 years of non-filing.

We have been directed by the Shriners International Temple Finance Senior Director that we need to provide a new EIN number because we utilize a bank. In order to get the new EIN we would have to change the name and re-apply for the new number. This requires a name change as long as it is not "International Association Legions of Honor." I have entered the name of International Legions of Honor. We need to supply a By-Law change to Shriners International. They will not move forward on this until they receive this information.


