ORDINANCE #584

AN ORDINANCE AMENDING ORDINANCE NUMBER 559 RELATING TO SERVICE CHARGES FOR SOLID WASTE DISPOSAL IN THE CITY OF WESTMORELAND, KANSAS, AND REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WESTMORELAND, KANSAS:

- Section 1. Section 2 of Ordinance Number 576 which amended Section 2 of Ordinance Number 563 which amended Section 2 of Ordinance Number 562, which amended Section 2 of Ordinance Number 559, which amended Section 2 of Ordinance 537, which amended Section 2 of Ordinance Number 495, which amended section 2 of Ordinance Number 423, which amended Section 2 of Ordinance Number 395, which amended Section 6.1. of Ordinance Number 338 relating to service charges for the collection and disposal of solid waste in the City of Westmoreland, Kansas, is hereby amended as set forth in Section 2 hereof.
- **Section 2.** The City of Westmoreland, in providing the services of collection and disposal of residential solid waste, shall collect services charges or fees to defray the cost and maintenance of service and to pay any person contracting with the City for the collection and disposal of residential sold waste. Such service charges or fees shall be as follows:
 - a. Residential Solid Waste Collection Fee For Persons or Residences Engaged in Contractor's Voluntary Recycling Program (Residential Collection Services plus Recycling Program): The following rates shall apply for those persons or residences engaged in the Contractor's voluntary recycling program: (i) For a single family residence where only one person resides, the rate for once weekly solid waste collection service and bi-weekly recycling collection service shall be the sum of \$24.75 per month per dwelling unit; (ii) For a single family residence where more than one person resides, the rate for once weekly solid waste collection and bi-weekly recycling collection service shall be the sum of \$26.75 per month per dwelling unit.
 - b. Residential Solid Waste Collection Fee For Persons or Residences Not Engaged in Contractor's voluntary Recycling Program (Solid Waste Collection Fee Only): The following rates will still apply for those persons or residences not engaged in the Contractor's voluntary recycling program: (i) For a single family residence where only oner person resides, the rate for once weekly service shall be the sum of \$15.25 per month per dwelling unit; (ii) For a single family residence where more than one person resides, the rate for once weekly service shall be the sum of \$17.25 per month per dwelling unit.
- **Section 3.** All ordinances or parts of ordinances in conflict herewith are hereby repealed.
- **Section 4.** This ordinance shall take effect January 1, 2022 and shall be in full force after its passage and publication in the official City newspaper.
