Changes to VA Caregiver Programs Being Reconsidered Amid Complaints

Veterans Affairs Secretary Denis McDonough said top officials will re-evaluate ongoing changes to the department's caregiver support program which could take away stipends from thousands of families over the next year.

"I am worried about the feedback we're getting," McDonough told reporters at his monthly press conference on VA issues. "We work for caregivers, we work for the veterans. We want to make sure that they're getting the information they need and clarity about why we're making the decisions we're making."

Earlier this month, a coalition of 15 veterans service organizations presented formal objections to planned department changes in the Program of Comprehensive Assistance for Family Caregivers, which provides stipends to family members who provide home care to elderly or infirm veterans.

Among the complaints were that the new rules "drastically changed the program's eligibility criteria" resulting in "harsh impacts" for families.

About 33,000 individuals are currently enrolled in the program, which provides support services and monthly stipends to caregivers of veterans unable to perform basic self-care activities.

The stipend is set to expand in October to include families of veterans who served between the Vietnam War and the Afghanistan War, prompting the department work to ensure that existing program participants are being treated equitably.

VA officials announced last fall that they expected around 6,700 families would be dropped from the program under the changes, but

that no families would see any financial payouts decreased or ended before October.

The idea was to ensure that individuals would have time to prepare for the financial impact of losing the stipends, which can total more than \$3,000 a month. But advocates objecting to the changes have nonetheless called them too restrictive and unforgiving, aimed more at culling families from the program than balancing veterans' medical and emotional needs.

McDonough said that in coming weeks, Deputy Secretary Donald Remy will head up a review on the work so far "to make sure that we're learning everything we can from and that we're making best

use of investments Congress has made in this program."

On the criticism the department has received, McDonough said he is unsure if it represents widespread communication problems with staff and participants, or simply a small minority unhappy with the personal impact on their families.

The secretary said officials do not have authority under the law to include veterans with non-service injuries (individuals must have a VA disability rating of 70 percent or more to qualify) but do have more flexibility in how they evaluate whether full-time caregiver services are needed to improve a veteran's quality of life.

He expects Remy's review to take several weeks, and look both at changes to the program and how

they are being communicated to the families involved.

"[Caregivers] will be a bigger part of the backbone as our aging veterans demonstrate that they, like the rest of the country, want to age in place," he said. "And so we want to get this right."

Vets' Disability Benefits for Tinnitus, Mental Health Issues May Change

Proposed changes to the Department of Veterans Affairs disability ratings system will mean lower payouts for veterans with sleep apnea and tinnitus in the future but higher payouts for veterans facing mental health challenges like post-traumatic stress disorder and depression.

The changes are part of a months-long review of the department's Schedule for Rating Disabilities, which governs how VA staffers evaluate and compensate veterans with service-connected injuries.

In a statement, Thomas Murphy, acting VA undersecretary for benefits, said the goal of the work was not to reduce or increase the number of veterans receiving disability benefits but instead to ensure that "veterans receive decisions based on the most current medical knowledge relating to their condition."

For veterans currently receiving those payouts, the changes will not take away any existing benefits or lower their disability rating. They could see their ratings increased based on the changes, if the new rules end up more advantageous to their health situation.

But veterans who apply for benefits in the future will see a different set of standards applied to their cases than their older peers, and that could have significant financial ramifications for those individuals.

Under VA rules, a disability rating of at least 10 percent can mean monthly payouts of more than \$140 for a veteran. One who receives a disability rating of 100 percent — either from a single service-related condition or a combination of injuries and illnesses — can get about \$3,100 a month in disability compensation.

VA did not provide any information on how the changes will affect its budget.

Outside critics have lamented that the current ratings system too frequently compensates veterans

for conditions that are treatable and do not prevent them from maintaining a full-time job.

But veterans advocates have said the system is still cumbersome and difficult to navigate, often forcing veterans to wait for months or years to get compensation for disabling conditions that are obvious to even those without a medical degree.

The number of veterans receiving compensation for sleep apnea — interrupted breathing during sleep — has risen sharply in recent years, from less than 1 million individuals in fiscal 2015 to more than 1.3 million in fiscal 2019, according to the department's inspector general.

Under proposed changes outlined in the Federal Register on Tuesday, VA officials for the first time could offer a "0 percent evaluation" for asymptomatic sleep apnea, allowing the department to formally acknowledge a veteran's condition without requiring any compensation if the condition is easily controlled with treatment.

Veterans would receive ratings of 10 percent or more for sleep apnea "only when treatment is either ineffective or the veteran is unable to use the prescribed treatment due to comorbid conditions." Currently, veterans can receive a rating of 10 percent or more for the condition even if treatments are effective at dealing with the condition.

Similarly, veterans diagnosed with tinnitus — a high-pitched ringing caused by damage to the ears — would face a higher bar for higher levels of disability compensation. More than 1.5 million veterans are currently receiving disability benefits for the condition.

Officials said those changes would likely reduce the number of veterans qualifying for disability ratings of 10 percent or more, although they noted the number of veterans who have the condition entered into their case files for future reference would not change.

MESSAGE FROM THE EDITOR

This will also enable the Association to save over \$600 a year by eliminating just one issue of the newsletter. So it's a win for all.

Secondly, our reunions were mentioned here, and so that is what I wish to address next.

Have you never attended a reunion? Are you a regular attendee? Maybe after these last two years, you aren't sure which you are. I want to attempt to generate some interest and excitement for the upcoming reunion this year in Gettysburg, Pennsylvania. Our shipmate, Bob DiMonte has organized a real winner for us.

Why should you try to make this one an attendance success? Well, frankly, I share our Association President's concern that with two consecutive cancellations due to Covid concerns, our Association needs to generate interest as a matter of survival. If you've been to a reunion, you already know the great time to be had, and you are encouraged to commit to attending again.

For those members who have yet to attend? Let me encourage you to do so. Why? Well frankly, you aren't enjoying to the fullest all that our association has to offer. When I first joined, I didn't know any of our members, and feeling awkward around strangers, I was hard pressed to bring myself to attend. But when there was one being held nearby, I was able to get off from work to attend one day's events, and was so welcomed by everybody, I felt like I'd known them for years. I was hooked, plain and simple, and I believe you will be too. The fellowship and friendships developed have been a blessing to my wife and me, and I look forward to meeting *you* as well. The comradery you remembered that caused you to join our association, is still there waiting for you, to make many new memories to enjoy.

We feel it is crucial to our survival as an association to have good turnouts for the reunions, and after two years of having to cancel them, we have an opportunity to set a record. With a tour of Gettysburg's battlefields, shopping and dining opportunities, raffles, and ton's of wonderful fellowship to be had, I don't think any of us will be disappointed.



In 2022, veterans who receive Department of Veterans Affairs (VA) disability compensation will see a sizable increase in their VA compensation checks. VA disability compensation is a monthly tax-free monetary benefit paid to veterans due to their service-connected disabilities; it compensates veterans for their decreased quality of life or adverse effects on their ability to work.
