APPROVE OR DENY PLANNING AND ZONING RECOMMENDATION FOR REZONE CASE # RZ25-06-03, 121 AND 139 SADDLE CLUB ROAD FROM R-1 TO C-1 Discussion

<u>Petty</u> - We have the minutes from the Planning and Zoning Commission meeting where it was unanimously approved to recommend to the Board of Aldermen to rezone these two lots from residential to commercial.

Stewart - And this is just her continuing her vision of improving that?

<u>McMains</u> - She just, I think she wants to do is rezone to commercial so she can merge all three properties. Now being that we did hear from a couple oppositions saying they weren't exactly in favor of it, which were her neighbors, I spoke to one afterwards and he said he wasn't in favor of it. I'm still in favor of just the simple switching it to commercial. I mean, she hasn't got through everything she wants to do yet, but this, it's just rezoning it so.

<u>Petty - And the primary property Legacy Early Learning Academy is already commercial.</u> So her two additional properties, which are adjoining to the daycare property, she's wanting to change those to commercial as well. She eventually wants to get it all rezoned as one. Which I think, you know, could offer her some benefits. But this is the first step in her overall plan to open up a learning, interactive animal learning experience.

Discussion

<u>Petty</u> – We have one application for Board consideration from Thomas Voorhis, who has expressed interest in being reappointed as the Mayor of Fair Grove.

When this Council flipped over we had some very big decisions among us and I had spoke with many Council Members who had voiced what they were going to do at some point and then it changed. And I felt all the hard work, all the dedication, all the long nights and getting chewed up on social media, out here in a meeting that the Council just flipped on me. And I put in a long, hard year of standing up against people. And when that happened to me, I did, I felt crushed from all the hard work I put in over the year. I, I felt betrayed. And I did. With that, I'll accept that responsibility and I am apologetic to the Community members that I let down. Thank you. That's all I got.

Petty - Any further discussion from the board?

Dayna Ault 133 E. Willow Street – How ya doing? It's fun to see this new board up here and we worked really hard to make some things happen. I guess my thought is concerning the mayor's situation. I think right now you're kind of in a pickle because you're missing also an Alderman and I personally think, I know there's a lot of options. A lot of ways that you can go. You know, choose a mayor, leave Kelly in her position voting twice if needed. You know, there's just there's a lot of different ways to, to scramble the egg. But I would like to see Tommy get back into the mayor position. I feel like he was, his heart is right and I think that he does see, we've had some discussions on the phone, he does see some places that he can can change and make this a better experience for everyone. So that would be my vote. I would like to see and that would free you up to do your job as Alderman and, and not have to carry the weight of both. I think he's going to be much more open to listening to the board and to the community as well, so I'm, you know, I would like to see that happen. I also want to applaud you guys for the the new setup where you take comments on each item. This needed to happen years ago, why did nobody else think of it? Hats off to you. Great idea.

McConnell - You're welcome.

<u>Jeffrey McConnell</u> - This is new to me, but for those who might be sitting on the fence, there's such a thing as appoint for a year or a probationary period, I think you could just appoint for a year or something to that effect. Whatever you have other ideas might come up with because we are short. That's just my suggestion.

McMains – He would be finishing out his term. It would be until next year.

<u>Petty</u> - So just to address the concern about my plate, I'm more than happy to serve the dual role until this Council finds somebody to appoint in the mayor position. I'm here to serve and I love doing it? So, thank you for the consideration.

Jackie Robinson - Hey, guys. You know, my name's Jackie. I'm not gonna give up my address because I really don't want it in the minutes. First of all, let me explain a few things. You're doing a very good job, and there's been a unison here lately it seems like on this board. Not fighting, not arguing. There's no harsh words being said. There's a reason for that, OK? As Mr. Voorhis just said, which I wrote a note, temper is not an excuse. There is no excuse and no reason to have a temper that extreme during the board meeting. The city did not deserve it. You all don't deserve it. There is no excuse for a temper. Second of all. If you can't handle the pressure, you don't need to be in the position. In other words, if you can't handle the heat, don't get in the kitchen. Because obviously he left because there was pressure. Second of all, he said about social media getting ate up on it, he himself has put himself as a victim on social media. He attacked. We all have. I have myself. So that's not even a reason itself. And he made it personal. He didn't keep it professional and his position that he was, it was personal. That's another problem because it's not for the person's personal future here is because you were elected for the people. So April the 1st or April the 7th, excuse me there was talks with the Planning and Zoning about a apartment complex to be built over here on CC. OK, it was purposely said for that reason. The water and sewer was mentioned that it was going to be a strain on it. It was also mentioned that the school was at max capacity. That this is going to affect the school, however, the mayor took it upon himself at that time to motion it to be in motion for the Alderman decisions or the Alderman meeting. Why if there's already a restraint. Then at the meeting on April the 22nd, he said it wasn't the agenda of the property, even though there was blueprints and it had already been discussed in Planning and Zoning. So, it was on the agenda to build an apartment complex. Why was he so strong about this? A mayor is to be a deciding vote if there is a tie. He is not to be promoting something that is for you guys, it is the mayor's job to be a deciding factor. He is not to be doing. It is not a promotional thing for him. Second of all, in the minutes he asked for, on this 22nd, he asked for a closed session and he didn't want the clerk to take the minutes. The clerk has always taken minutes, even in closed session.

Cooke – No.

Robinson – Okay, I stand corrected, but why he requested it personally, why? He wasn't going to give forthright that information. He just said he didn't want her to do it. We as people were wondering why and we never got that answered. Then he, on the 22nd, the mayor wanted to be added on to the safety deposit box. Everybody said no problem. Then when Bell talked about the school attendance, he basically said that it was the school's problem, not us. Well, I'm sorry, that is our problem. Then on May the 13th, it was brought to our attention that there was legal issues of being on the attorney and that we went over our budget. There was personal. Things that he said that he was 90% transparent, you're not 90% transparent. He even said there was things that he talked to the attorney that he did not feel like was needed and was or not city in business.

Robinson – I've got the quote from the minutes.

<u>Petty</u> – We're at time. Would you like to make a closing statement?

Robinson – I would like to make a closing statement. Why is he being considered when you all took him off committees on May the 13th? You took him off of all the committees. You took him off the signing of the checks. I can quote you guys if you want. He also stated on that day that this was his meeting. It's not his meeting, it's the city's meeting. Not his. He did everything on personal issues and not professional. I want you to consider that because he left and his exact words was I see where we're going and I see what this what the people, the city wants, and I've got that quote to, so I'm leaving. So if you are listening to what the people want, what the city wants, they applauded when he walked out.

Petty - Thank you, ma'am.

<u>Voorhis</u> – Am I allowed to speak, Mrs. Petty?

Petty – Yes. You will have 3 minutes, Mr. Voorhis.

<u>Voorhis</u> - Just a quick response to to some of that. The city clerk has never been able to sit inside closed session without the permission of the Council. This Council has never operated in that way, so by no form did I ever say that to to keep Miss Davis out of that meeting. The ladies and gentlemen on this Council knew what that closed session was supposed to be about. And if you don't, you do now. Because we spoke about it. What I wanted to talk discuss in that closed session and I thought it was open communicated at first to begin with. I'm sorry if if it wasn't that way for you guys because you know why I intended not to be, uh. Second, she has her opinion. I would like to say the majority of people that came up here and spoke against me is not the majority of that Community of Fair Grove. I have spoke with a lot of the community members and I would ask that I get reinstated. That's up to you guys and once again. I would greatly appreciate that. So thank you.

Robinson – I have a rebuttal on that. Just for a second. There's 1300 people in the city. He did not talk to all 1300 people. He has walked out. He has spoke his say. And as far as the other thing about the meeting, I said I was wrong. So that being said, that's fine, and the other people that spoke that night they are the city, so they have a voice and they should have been understood and heard. Not just because you went and talked somebody that didn't come to the meeting does not mean that they all agree with you or anybody else. The ones that showed up, are the voices that should be heard.

<u>Petty</u> – Thank you.

Robinson – Thank you!

<u>Tyler Kleinlein</u>, 437 S Waterfield - I think to Dayna's point. I think there's an easy decision and there's the right decision and knowing Pro Tem Mayor Petty's opinion on carrying the

So, I'm not saying that you're not qualified to be mayor, I think there needs to be some time and I think you need to learn a little bit about yourself and how to manage stress and be for the city and for the people and not for yourself. Ault - Is there anybody else that has put in?

Petty - Not at this time.

Petty – Anybody else like to speak?

<u>Petty</u> - At this point, if the mayor, an interim mayor, can be appointed or recommended, nominated, that's the right word, nominated for appointment to serve through the remainder of this open term until the next election. If there is no nomination then the position will remain open with the Mayor Pro Tem stepping in until someone is appointed or until the next election.

Stewart – Tommy, you did a great job for us for a year and it really nosedived in January. And I think because of that you have a split vote up here. Just to me discussing this with them prior to the meeting. I would like to see us stay as one solid group working together up here, we've worked hard to do that and I think that we're going to have to. But I would like to see us put out on social media and maybe see if we can get some interested parties or somebody else putting in for it. But I do thank you for your service that you did and I think you did great job. And we had the turn of events. And it went downhill. And I wish you wouldn't have walked out that day. I wish you would have stayed up there and we could have worked it out.

<u>Petty</u> - So the social media, I'm sorry, the public relations committee will create a Facebook posting for the mayor position to advertise that this is an open role with the city and instructions and on if they are interested. Of course, they would go through the same process of putting in an application and coming to speak with the board and answer questions from the public.

Stewart - Thank you.

<u>Hodges</u> – Are we going to vote on this? On nominating him.

Petty - At this time, nobody has nominated him.

Almost everybody know the what he went through up here, since I became on here and before that, I was here. He got drilled so hard up here that nobody, there ain't nobody sitting here, that could have took what he went through. Discussion

<u>Petty</u> - We have two applicants for the Ward 3 Board of Alderman seat to be filled until the next election for Ward 3. First is Eric Boncuk.

<u>Eric Boncuk</u> - We've been residents here for about. 3 1/2 years now. The opportunity to presented itself with an Alderman seat to be filled. And I just believe at this time that is something that I would like to step up into. You have the great community here. I never got involved in the first few years we were here. I just now got involved with the PCAC last year. I was instrumental in that and getting that going and getting it to be a thriving the organization. But with looking at time, there wasn't something I would have liked to go farther than that. But I retired last July, and I just feel this would be the time that I would be able to dedicate myself to this.

<u>Petty</u> – How long have you lived in Fair Grove?

Boncuk – 3 ½ years. We relocated down here from Lincoln, Nebraska with Costco because I was a manager at Costco. We came down here to help open that building and get it established and the time I hit 65 and I'm like yeah, you know, like, you know, I'm going to do this for now.

<u>Petty</u> – Is there any particular area within the city business that you feel passionate about or? Or excited to learn.

Boncuk - A couple of different things I'm interested in. I'm interested in the in the sewers and streets and such like that because I know that becomes a problem having lived in a lot of big cities. I know infrastructure if you don't stay on top of it, it will start to fail. I'm originally from Pittsburgh, PA, and half those bridges are in dire need of repair at this point in life. We moved away from there as a little kid and my wife and I move back there for about four years as adults. So that's always one that's interested in me because again it's very vital you keep those things going. Another area would be in the social media aspect because it's like as we're coming as I've been at some of these meetings recently it seems like the Council is coming into an area where they're starting to see the need for streaming their meetings and things like that. I lived in Vegas for a lot of years and found myself on Monday and Tuesday nights sitting there just watching them. There was one gentleman that spoke on every single thing that came up, whether he had anything to do with it or not. But he was exercising his right to decision, which was awesome to see.

<u>Stewart</u> – I assume you've been warned about the hours?

<u>Boncuk</u> – Oh yeah. I know that there are many hours involved in it and again, having been, I worked in retail my whole life. Boncuk - My favorite thing serving on the committee is just seeing something starting from the ground up and just seeing how the fact that was so well received by our Community and that tells me that our community is looking for something like that. To see last year's and I have to preface by saying, because of vacations that were planned, I wasn't there for nightly night, National Night Out, or shop with cop. That again seeing how well they were received seeing the. The fact that this community donated so much, we had a goal for shop with a cop of X amount of dollars and that was fun. We ended up getting from this community five times that amount. So instead of helping 10 or 12 kids, we were able to help 58 kids last year. That just shows that this community comes together for itself. Seeing this past year, the way they come, they come together for that young man Cooper Roy, it's just phenomenal seeing that. So with all the distractions of all the keyboard warriors that like to get going on things, it's nice to see that deep down the heart of this community is let's come together and solve things.

<u>Chris Robinson</u> – So that I understand, you are fully retired?

<u>Boncuk</u> – I am fully retired except for working for now Caroline because Megan *inaudible*.

Robinson - Well, that's, you know, to me that's an advantage because you have more time than anybody else sitting up there right now to vote. You could do the legwork work more than most

<u>Boncuk</u> - Which is kind of why I took the position up there a couple days a week and after several I had had surgery last February on my arm. We went in to get a coffee one day and Anna is like Eric. How you doing? Great. Steph, how are you? So and after 48 years in, in engaging with people you know in retail. I don't know how to sit at home. I don't know how to not talk to people.

Robinson - Kind of figured that's why you were working over there.

<u>Boncuk</u> - Yeah, you can't be a retail 48 years and not enjoy talking to people. A couple weeks ago I talked to this girl for about 15 minutes and it was great talking to her. She's very, I could tell through our conversation that we probably wouldn't agree on a lot of things but we found common ground and she actually ended up leaving a yelp review and Anna was like check this out.

Robinson - I think that's a reason you're a problem solver, not a problem maker.

Boncuk - I'm trying to be that.

Jackie Robinson - Now you're from Ward 3. Have you gone around to talk to any other people?

Boncuk - I have not at this point, no.

Petty – Okay. Thank you, Eric.

Boncuk - You're welcome.

<u>Petty</u> - The second application we have for Ward 3 interim Alderman in Brady Dickens. Which I don't think is here tonight.

<u>McMains</u> - No, he unfortunately had a meeting done in Branson that was at the same time as this one, so.

Petty - Do you wanna read this letter?

McMains – That would be great for our Interim Mayor.

<u>Petty</u> - Alright. He did write a letter, however, to this Council, which I will read now. (Letter attached) Would anybody on the board like to speak on his behalf?

<u>McMains</u> - I would because I, just you know, I brought him here so. I know he, he expressed regret that he couldn't make it here and he understands that if it cost him that seat. I think he'd be very good as a ward three candidate because he is so involved in the school. He has two

Ault - Is he only interested in interim or is he thinking forward as far as putting in for the next.

<u>McMains</u> - He was going to win the last election, but because of the number of people that were kind of interested in it, he didn't want to split votes and it go one way rather than the other.

<u>Petty</u> - The process for this, for appointing an interim Alderman is the mayor makes the recommendation and the board approves. You know, thinking it would be a good idea to have an Alderman representation there because the mission is really to connect the citizens with our emergency services with our police officers and our now fire department for the shop with a hero, right? So all inclusive really finding the ways that we can help bridge the gap between the city and its residents. I volunteered to be the Ward 2 representative that went to those meetings. In that, this past year plus, I got to see Eric on the committee performing and participating, and he does bring passion and deep care for the city and the mission of that committee. Discussion

<u>Stewart</u> - This one was something that we brought up last meeting about the fact that the chief cannot hire his own police officers he has to ask our permission to hire these officers and we hire them. I think it's silly. Like I said, last meeting, I think I joked about it. But and this is basically allowing him to do that. He gets to hire his own cops. Hire his own cops as he sees fit and as our budget allows.

<u>Petty</u> - Basically, trusting our Chief of Police to be the chief of police and make his decisions. Cooke - Yes, really pretty much, yes.

<u>Petty</u> - He would also take full responsibility for all officers that are under him as far as like making that decision to hire and ramifications with that, but.

Hodges – How do other towns around us do it? Strafford? Willard? Ash Grove?

<u>McMains</u> – Pretty much the police department runs the police department.

<u>Hodges</u> – That's the way they do it then?

<u>Stewart</u> – The Emergency Response Committee has discussed this and we're all unanimously in favor of this.

<u>Hodges</u> - Right. I'm just asking. I didn't know how, I didn't know how the other police departments, but. But is it automatically if he hired somebody and the Board feels we don't want them on there. Do we lose our rights to say no?

Stewart - It's the Chiefs decision on who he hires.

McMains - And the chief is going to be the one that's doing all of the background information of talking to them and all of that. For them to come up here within 15 minutes and talk to the board and say, hey here I am. Here's my resume. So I put all my faith in the chief's decision making ability.

<u>Hodges</u> - I'm just asking. I'm just wondering how the others do it because in the past, it's been the recommendation of the mayor wasn't or something? Is that how it's been?

<u>McMains</u> – They would bring the officer up to the board and do the whole introduction. Then they would vote on yes or no.

<u>Cooke</u> - And quite frankly, Franklin, and I've said this for for a long time. As we sit here now, there's two of us that might be qualified to determine what's going to make a good police officer. If we've hired the chief and we trust the chief to run this department, we need to put full trust in that chief to run the department. He may have, and I've seen this before, he may have an outstanding candidate that the board may not feel is cool enough or they can't get along with and we may miss out on a good candidate. That chief's gonna know who's going to work for his department way better than any of us will.

<u>Stewart</u> - Yeah. I think we've had past situations where maybe we missed some because of the way it's working with the way it's currently set up.

McMains – We can't be 100% on good employees. There may be that one off...

<u>Hodges</u> - But the chief won't be allowed to fire anyone. It'd have to come before the Board. If somebody is brought up.

Davis - What?

<u>Petty</u> - Does the chief have the power to terminate a police officer?

Davis - No. No, that has to come before the board.

Petty – There's also several things with the officer Bill of Rights that I think, yeah.

<u>Davis</u> - Correct. Yeah. There's a whole thing.

Petty - It's not a simple.

<u>Stewart</u> - This is the wording and this just says the chief of police shall appoint any other police officers found by the chief of police to be necessary for the good governments of the body of the city. So, that has nothing to do with firing, it's just hiring.

Petty - So the the difference is the city keeping what we have right now is \$250 a month.

So there was like a discussion with that. I know that we don't, really print a whole lot. We mostly use it just to kind of scan things in. But I want to say like the maintenance for that, especially when it comes to Altec, sometimes can be a bit difficult. Like when we're having to set stuff up and try to link it to our computers and all of that other stuff.

Petty - Does that cost money?

<u>Davis</u> - No. We have a service agreement with them.

Petty - For free?

<u>Davis</u> - Well, I mean, it costs \$200 bucks a month for all of City Hall and all the Police Department total, so.

<u>Petty</u> - So there would not be a cost savings associated with you getting a new printer through this. They would still have the same service cost for the entire...

<u>Sgt. Deckard</u> - I think just like if you guys went that route with giving us the one that you guys have, I know it's like updated, it's better, probably less complicated in some areas that we use it for.

Petty - Does the city need a new printer?

<u>Davis</u> - No, not necessarily. I mean the one that we have works great. We could do like where we keep it and share it with the Police Department like we've done in the past. Or we can get the city in new one because I don't know. Whatever you guys want to do. It works great.

McMains – We just got a new one like 2-3 years ago?

Davis - Something like that, yeah.

<u>Petty</u> - If you guys are in agreement, I think it's a good way to save some money considering that we have just eliminated 500 of your 600 monthly average pages with going to electronic packets, so we're going to use it a lot less as is. With the Police Department's minimal usage if it helps them, I don't know the distance. If there's any security restrictions with using that printer in place of the one that they have for sole, you know police business. But if it if it makes sense, I think this could be a good way for the city to have some cost savings and keep the current printer, which works well and we're reducing the usage of, so it should last longer even with the one page a month from the Police Department if that's allowed for confidentiality purposes.

<u>Stewart</u> - So, they'll probably have to print from theirs, but I don't know why they couldn't scan stuff in through yours. If they had to print some paper that had a victims information on it, they could not print that through the cities. They would have to use their printer. Outside that, I don't see. I can't think of anything, unless you can.

McMains – Not off the top of my head, no.

<u>Stewart</u> – Am I reading this right? \$58 is one of the options and our next lowest option is \$215 and then \$250. Is that pretty much what we're looking at?

<u>Davis</u> - So the way that I read it is if you wanted to buy out the device that we currently have, it's going to be the \$3,280.93 total and then it's \$58 a month for the maintenance of the printer.

Stewart - Gotcha.

Cooke - Yeah. So it would be that \$3,200, then the \$58 a month.

Davis - Yeah.

<u>Stewart</u> - But in order to do Option #2 here it's showing that we own it so it would not also have to buy it out.

<u>Davis</u> -. It would be doing basically a monthly buyout of it.

Petty - It's a spend unknown.

<u>Davis</u> - Yeah, because that's for the Police Department. We don't know what their usage is, that's why I said it could change if they printed a lot.

Greg Porter - So, happy to report that Tom has completed his IS 2200 which was one of the requirements for us continuing to receive by EMPG funding. I completed it a little bit earlier in the year. We both now. We have 24 months to do the IS 2300, so we are now searching to find it's like a four day course. We're trying to find something close that we don't have to travel across the state or anything like that to cut cost. And I think there's times that they do it online as well so just trying to get that so we can continue to receive those funds. Quarter 4 has been turned in and has been paid by the state. So 24-25 Grant has been submitted, paid and closed, which is a great thing. Earlier, in the month of July, Tom and I went to the SWMSO meeting that I reported last time. Just kind of kind of filling in on some of the things that they filled us in on and one of the cool things I think, especially with some of the flooding and things that we have here in the state is they're coming out with a new or, they're trying to come up with a new MWS flood map. Which is going to, it's going to be like a situational map. So as the forecast comes in they will be able to determine and say there's going to be a sprinkle, so we know CC's going to flood. But at 1/2 inch we need to start monitoring so we can start putting some situational awareness type stuff in for the potential of flooding in the area.

Petty - So it predicts the level of flood and the location of the flood severity based off of the weather forecast?

Porter - Yes, and it's it's basically given us, hey, this is the forecast, this is what you can expect. This is the potential threat or by picture these are the roads that you can be thinking that maybe flooding and whatever based on this forecast. So with that, I know Tim that you like to go out

and you like to take pictures and all of that good stuff. So one of the things that they are asking for is getting, I guess there's a free apps out there, timestamp where you can take a picture. It will GPS coordinate on that picture along with the exact time so they can go back and monitor and you can say okay, this is flooding at this point. They can go back and time that to what the radar has indicated the amount of rain that we've had at that point and they can start piecing some of this stuff together to say hey this is a 4 inch rain. This is what we were showing by. This is the levels of things of that nature, so it's some pretty cool stuff that they're working on. *Inaudible* which would be great. We are to the trials and you know in the beta form and all that good stuff now. But if you think of it or anybody else that wants to present any pictures try to do that time stamp so we can help them help us so we can make better decisions.

Petty - Do you plan on like publicizing this on social media to see if you can get more community members involved in snapping these pictures?

<u>Porter</u> - I can. I haven't. They're kind of in the beta, so they're kind of just trying to piece it all together. So until they kind of branch it out, that's the reason I'm just kind of just bringing it to you guys to let you know what's I thought that was kind of cool and be great situational awareness for us. Also. During that I also learned a new organization that I had never heard of that might be something that could be beneficial to our community and it's called Crisis Cleanup. And what that is is basically it's a non for profit organization that vets and I guess they do background work on people who want to go and do storm cleanup. So if a storm or a storm comes through and we have lots of damage the residents of our community can go on and register on this site and then organizations go to these people and they send people out to start doing clean up so.

Petty - For free.

<u>Porter</u> - It's kind of a cool. Yeah, it's. But here is the information just so you guys can have it kind of look over it. They go to anywhere. They go around the country and they're just coming into Missouri from the way I understand it.

Hodges - So it's not going on right now in Springfield area?

<u>Porter</u> - Yeah, it's a free service. They vet, they get these organizations, I know like whenever the storm came through Greene County and we got hit not too long ago there was the Baptist Foundation contacted and was looking for places to go and I'm like well Springfield got hit a whole lot harder than what we did. So you know. I think for what everybody was telling me, we were good here but like I said, it's a great, great resource for the community. To be able to go on and say hey, we need we need help in this area and these organizations go in there and they can look and start dispatching people up to serve. And then the other thing that we needed to because we got a lot of new people, several years ago, we adopted an ordinance and I know some people. So our our tornado sirens are an outdoor warning system. They're not a tornado warning system. They're an outdoor warning system for any threats that could be and it's for events that are outdoors not necessarily indoors. So I just wanted to bring your all's attention that several communities in the last few storms that we've had have been activating the storm sirens and we signed the ordinance. It was kind of a Region D coordinated thing that any storm that can

produce 70 plus mile an hour winds and there is an outdoor event we could activate the sirens. To let the Community know, hey, there's a threat go indoors, shut down the event. So football game, the festival, something like that. We've got a big event and and a thunderstorm that is producing 70+ miles per hour winds, we could activate. Which was put in ordinance. It was back whenever I was in put in Emergency Management before coming back on. They just kind of wanted us to reiterate because some communities got very upset that they were setting off the sirens but there was no tornado. But it's an outdoor warning system not a tornado warning system. So just bringing that to your all's attention, if that event does arise and they're activated you guys kind of know and can answer some of those questions or whatever and then.

<u>Petty</u> - That could be a good information.

Cooke - Yeah. That's what I was thinking.

<u>Porter</u> - And then the last thing is on October the 1st is our next meeting that they are inviting the Mayors to come to. We're doing a tabletop exercise to...

So I think some of these communities are getting hit, but they're not leaving that threshold and they're not receiving federal dollars and they're getting upset that they're not getting these federal dollars. So they want to do a tabletop so it's kind of getting you guys prepared or getting the information. It lets you guys kind of know what it takes, how it goes through the process and all. That stuff. So.

I and I grant money from two years ago, we still have about \$65,000 of that grant money that we need to spend by the end of this year. We already have a contract with Lafollette to to start that work. The the first portion of that work was the camera work that you've heard the previous board talk about. And we are already under contract with La Follette to continue some of the I and I work already identified on their contract that was from that study by the end of this year. As a continuation of that, we know that part of the general obligation bond will be used to cover additional I and I work. We have our first meeting with the bond company/bond attorney on August 7th to talk through what accessing that money looks like. What are the next steps for the city? Basically, all of the the next steps to get that money so that we can start working on the projects. One of the top priority projects is getting the culvert on South Main St. replaced to widen that area so that phase two of the sidewalk project can be completed by the end of the year. We have biweekly meetings with Morgan Neal with OWN construction. He is working with Modot to move that project through. There are several steps still left to take place before we can actually put out for bids. Once Modot approves the preliminary drawings, then we're looking for right of way approvals from MoDot and and the third party company that they contract through. We will then be talking to actual homeowners to hopefully get them to sign for the easements that we would need to be able to install those sidewalks. So that is where the sidewalk project is. We have until the end of this calendar year to complete Phase 2 Sidewalk project, which is why we have the biweekly meetings with Morgan to ensure that those are moving. We have a little longer for phase three. Ideally we could get it all done concurrently.
