

Join The 75+ SCWD members and members from other Midwest Regional Divisions who are participating in the SCWD listserv. You can expect 4 - 6 photos of railfan photos or model railroad photos per week on average, as well as SCWD announcements, and a monthly Mystery Photo contest. The listserv has been running this since April 2012 (that will be 7 years this coming April), and it has been quite popular.

The listserv is a one-way email broadcast to you, not a social media type service. The emails are sent in bulk, but as a BCC: type email, so no one knows the identity or email addresses of the participants. Once a month, I send out a Mystery Photo, and then if you know the answer or do a little research , you send an email back to <u>scwdmemberlist@frontier.com</u>. About a week later, I post the answer and a list of the names of those who sent in answers that month. The answer often includes parts of the best correct answers received.



Why We Have Time Zones

Time zones were invented in 1883 to solve an increasingly serious problem. It was becoming impossible to know what time it was. The United States had no standard time. Ever community kept solar time, meaning that noon was whenever the sun was directly overhead at that location. This meant for example that noon was several minutes earlier in New York than in Boston.

This had always been true. A typical day's travel by horse covered about six miles which had a time error between start and finish of about three minutes.



But railroads were the first business that covered enough distance to make it matter. Across a hundred miles, suddenly you were off by an hour! Both freight and passenger service depended on accurate timetable and performance. In 1883 the railroad was keeping track of fifty-six time standards.

Several railroads developed independent methods to solve the problem. The first real attempt was by the Pennsylvania Rail Road which used Allegheny Time. Unfortunately, almost everyone else used New York Time or Chicago Time.

Needless to say, this was all being calculated by hand and was different for each line depending on its latitude, since the width of an hour changes with latitude. After the Civil War, things got *really* bad; because there were now very large western distances to cover, and the inhabitants depended absolutely on the railroads. It was intolerable and something had to be done. It was.

As early as 1870 Professor Charles Dowd had proposed the establishment of fixed time zones. His suggestion was largely ignored by the railroad industry.

The General Time Convention (renamed the American Railway Association in 1891), an organization of US railroads charged with coordinating schedules and operating standards, became increasingly concerned that if the U.S. government adopted a standard time scheme it would be disadvantageous to its member railroads.

Finally, in the spring of 1883, the leaders of the nation's railroads sent representatives to a meeting of what was called the General Railroad Time Convention. The first suggestion was two time zones centered on Washington and New Orleans. This was quickly seen to penalize the increasingly populated Western part of the country and was rejected. But the discussion of time zones had paved the way for more sophisticated discussion of the concept.

The next idea to be seriously discussed evolved into four "time belts" set to straddle the 75th, 90th, 105th, and 115th meridians. After more discussion and refining, on April 11, 1883, in St. Louis, Missouri, railroad officials agreed to create five time zones in North America: Provincial, Eastern, Central, Mountain, and Pacific.

Six months later, on October 11, 1883, the General Railroad Time Convention met again in Chicago. And it was formally decided that the new standard of time would take effect a little more than a month later, on Sunday, November 18, 1883.

As the date for the big change approached, newspapers published numerous articles explaining how the process would work.

The shift only amounted to a few minutes for many people. In New York City, for instance, the clocks would be turned back four minutes. Going forward, noon in New York would occur at the same moment as noon in Boston, Philadelphia, and other cities in the East. In a parallel to the famous Y2K problem a century later, jewelers used the event to drum up business by offering to set watches to the new time standard. And although the new time standard

was not sanctioned by the federal government, the Naval Observatory in Washington offered to send, by telegraph, a new time signal so people could synchronize their watches. The government would not formally adopt the system until the passage of the Standard Time Act in 1918.

There was very little resistance to the change the railroads had wrought. The advantages to business and travelers was so obvious that the few objections were quickly extinguished.

The system went worldwide within a year or two. Most countries were small enough that they could be comfortably covered by a single time zone. The advantage of synchronized time across Europe led to the adoption of the system there within a year or two of the U. S.'s system in 1883.

The system is now such second nature that few people realize that it was invented by the railroads. Ironically, the first to propose the system, Professor Charles Dowd, was run over by a locomotive in Sarasota New York in 1904.


Cold weather is here, so keep working on that layout. New/Old stock coming in daily. Shelves are full. Looks like everyone will be staying home this holiday season.

We are back to our normal hours Monday-Friday 10:00-8:00 and Saturday 10:00-5:00.




