

# Bloomfield Police Department

## Monthly Report for October 2017

This is the monthly report for the Month of October 2017 from the Bloomfield Police Department. It is the police department's goal to keep the citizens of Bloomfield Township/Village informed as to the police department's activities, statistics, and community projects. It is very important that the citizens be aware of the various concerns that have and are occurring within our community.

On Monday, October 2<sup>nd</sup> at approximately 11:15am officers received a violation of court order/restraining order complaint. At the conclusion of the investigation a charge of violates/harassment restraining order was forwarded to the Walworth County District Attorney's office for a 31-year-old male.

On Tuesday, October 10<sup>th</sup> at approximately 4:04pm officers responded to a personal injury crash in the area of Hwy 120 and Bloomfield Road. At the conclusion of the investigation a 38-year-old male was issued a traffic citation for improper turn into a driveway/private road.

On Wednesday, October 11<sup>th</sup> at approximately 1:53am officers responded to a single vehicle crash in the area of Hafs Road and Bloomfield Road. At the conclusion of the investigation a 26-year-old male was arrested for operating a motor vehicle while intoxicated 1<sup>st</sup> offense. Additionally, the driver was issued a traffic citation for failure/improper stop at a stop sign and a non-traffic citation for resisting/obstructing a police officer.

On Saturday, October 21<sup>st</sup> at approximately 8:52am officers responded to an assist to fire department request in the 100 block of Hwy U. While investigating the fire ignition source officers located an uncontrolled burn in the area. Officers attempted to question an agitated 55-year-old male about the uncontrolled burn. At the conclusion of the investigation the male was arrested and confined in the Walworth County Jail. Charges of disorderly conduct and resisting/obstructing a police officer have been forwarded to the Walworth County District Attorney's office. Additionally, the male subject was issued a non-traffic citation for an uncontrolled burn violation.

On Monday, October 23, 2017 at approximately 3:43pm officers responded to Star Center School for an unresponsive female seated in a vehicle. At the conclusion of the investigation a 34-year-old female was arrested for operating a motor vehicle while intoxicated 2<sup>nd</sup> offense with a passenger under the age of 16. A charge of operating a motor vehicle while intoxicated 2<sup>nd</sup> offense with a passenger under the age of 16 and open intoxicants in a motor vehicle (driver) have been forwarded to the Walworth County District Attorney's office.

On Wednesday, October 25<sup>th</sup> at approximately 9:35am officers responded to a criminal damage to property complaint in the Nippersink area. Person(s) unknown using red spray paint damaged several areas which include but not limited to the bridge, a stop sign, a no parking sign, and concrete boat launch. This incident remains under investigation.

On Saturday, October 28<sup>th</sup> at approximately 2:56pm officers received a battery complaint which had occurred on Linden Road. At the conclusion of the investigation a 56-year-old male was arrested and confined in the Walworth County Jail. Charges of substantial battery and disorderly conduct have been forwarded to the Walworth County District Attorney's office.
