## Why NOT a Constitutional Convention?

Every 20 years, by New York State Law, NYS residents are asked a simple question. This question will appear on the ballot in 2017:

*Shall there be a convention to revise the constitution and amend same?*

**There are two ways to amend the constitution:**

- Pass an individual bill through two sessions of the state Legislature. This is how casino gambling (2013) became law.
- Hold a constitutional convention, which COULD result in full re-write of our Constitution. Delegates are CLEARLY those folks currently in power (members of the legislature, political parties, and office holders). Proposed changes are then submitted to the voters for approval or rejection.

**Why is this important to my family and me?**

Changes can be made to the fundamental rights, which you have:

- Guaranteed free public education
- Prohibiting reduction in public pension benefits
- Rights to Workers Compensation
- Rights to join a union and collectively bargain
- Requiring NYS provide for social welfare needs

**If YOU were a state legislator, what might you want changed?**

- Expand state funding to private/religious/charter schools?
- Reduce public pensions?
- Remove the right to bargain and join unions?
- Reduce food stamps and/or rent subsidies?
- Remove environmental protections?

Residents of NYS should vote **NO**. There is sufficient ability to amend via the normal legislative process. In that process, transparency and legislator accountability are KEY to any changes. To learn more about this issue, or how you can be involved, visit the MAC at NYSUT.org.

**NOTICE:** The December 16, 2015, end of year budget deal between congressional leaders and the White House did not repeal the "Cadillac tax" but delayed it for two years raising doubt about whether it will ever take effect, especially now that every major presidential candidate opposes it.

The Budget deal defers this tax on expensive employer health plans. The new tax has been dubbed the "Cadillac tax" because it applies to high-priced health-insurance plans only. If this tax is not changed or repealed, many NYSUT members would be negatively impacted by a dramatic increase in taxes on their health-insurance plans.

## Waiting for the other shoe to drop!

What can a court case about a California teachers association have to do with New York State retirees? Well, the answer is a lot!

The case which was just argued before the Supreme Court, Friedrichs vs. California Teachers Association, can impact the future of all public sector unions in the country and laws about unions in every state. We are all waiting to hear the results of those arguments which were set to be published in June.

If Ms. Friedrichs wins her case, she would no longer have to pay her union any share of the dues although she would receive all the benefits of collective bargaining. This doesn't seem "fair" to us as members who knew the dues that are paid by members allow the union to carry out activities to improve working conditions and protect individual rights.

If "Fair Share", or agency fee as it is known, is found to be unconstitutional, imagine what might happen to union membership and the union's power to represent, negotiate, and defend Social Security and Medicare for retirees, let alone, all the classroom issues we hear about.

The unexpected death of Justice Scalia added another wrinkle to this possible crisis. Because the decision of the justices was not published before his death, the case might be void and the lower court's decision upheld. Thus public employees are nervously waiting for the sound of that shoe.

NYSUT's legal department tells us that there are other cases making their way through the courts which would be as disastrous for union rights. All of them showing attacks leveled at education's issues like tenure, seniority, as well as fair share.

We retirees built the union and we always expected it to be there for us - to protect a stable and dignified retirement, but, as we have learned through the many attacks on public education, defined pensions, union rights and labor, we cannot assume that the union will stay strong without retirees staying informed and ramping up their activism. Be mindful of that when asked to write a legislator or attend a rally to stand up to our attackers.

## It's Time to Apply for a Scholarship

Each year, RC7 awards up to three scholarships of \$1000 to qualifying children or grandchildren of an RC 7 member (whose participation fee was paid by December 31) who will graduate from any New York State public high school or any private/parochial high school whose staff is NYSUT affiliated and who plan to enter a profession requiring higher education at an accredited institute of learning.
