

Ordinance No 608.

An Ordinance Appropriating certain Money's.

Be it ordained by the Mayor and Commissioners of the city of Garnett Kansas.

Section One:- that the sum of *Two Hundred and Twenty Five and 3/4* Dollars be and the same is hereby appropriated out the General Funds in the hands of the City Treasurer to pay the Bills allowed against said Funds at a regular meeting of said Board held on the 7th day of September 1914. a list of which may be found on page 173 of the Journal of the proceedings of the Board on said date.

Section Two:- that the sum of *Three Hundred Forty Six and 7/8* Dollars be and the same is hereby appropriated out of the Water Works Funds in the hands of the City Treasurer to pay the bills allowed at a regular meeting of said Board held on the 7th day September 1914. a list of which may be found on page 174 of the Journal of the proceedings of the board on said date

Section Three:- that the sum of *One Hundred and Eighty Three and 7/10* Dollars be and the same is hereby appropriated out of the Street Fund in the hands of the City Treasurer to pay the Bills allowed against said Funds at a regular meeting of said Board held on the 7th day of September 1914. a list of which may be found on page 174 of the Journal of the ~~proceedings~~ *proceedings* on said date.

Section Four:- that the sum of *Four and 5/100* Dollars be and the same is hereby appropriated out of the Cemetery Fund in the hands of the City treasurer to pay the Bills allowed against said Funds at a regular meeting of said Board held on the 7th day of September 1914. a list of which may be found on page 173 of the Journal of the proceedings of the Board on said date.

Section Five:- that the sum of *Two Hundred and Eighty Five and 7/100* Dollars be and the same is hereby appropriated out of the Water Works extension Bond Funds in the hands of the City treasurer to pay the Bills allowed at a regular meeting of said Board held on the 7th day of September 1914. a list of which may be found on page 175 of the Journal of the proceedings of the Board on said date.

Section Six:- that the sum of *Twenty and 6/100* Dollars be and the same is hereby appropriated out of the Electric Light Bond Fund 1913. in the hands of the City treasurer to pay the Bills allowed against said Funds at a regular meeting of said Board held on the 7th day of September 1914. a list of which may be found on page 174 of the Journal of the proceedings of the Board on said date.

Section Seven:- that the sum of *Four and 7/100* Dollars be and the same is hereby appropriated out of the Funds of Sewer District number One- in the hands of the City Treasurer to pay the bills allowed against said funds at a regular meeting of said Board held on the 7th day of September 1914. a list of which may be found on page 173 of the Journal of the proceedings of the Board on said date.

Section Eight:- That the Mayor and City Clerk are hereby authorized and instructed to draw warrants on the city Treasurer to pay the Bills allowed in Sections One- Two- Three- Four- Five-six- Seven- of this Ordinance.

Section Nine:- that this ordinance shall take effect and be in force from and after its passage by the Board of Commissioners and its approval by the Mayor.
