Commissioner Fluty made a second to the motion and the motion carried.

The Commissioners discussed removal of leaves for this season. Commissioner Fluty made a motion to allocate \$1,800.00 for removal of leaves. Commissioner Miller made a second to the motion.

Commissioner Fluty made a motion to approve purchase of a bond for the City Clerk. Commissioner Miller made a second to the motion and the motion carried.
