Grays Harbor District Report

Arrivals YTD March 31, 2019 were 21 for a total of 59 jobs. Capt. D'Angelo will has had the duty in March and April without any issues with fatigue management rules. He is scheduled to have the duty watch in May providing Capt. White an additional respite month after a very long duty watch. We anticipate 7 arrivals in April 2019. Our arrivals are tracking about 30% behind budget and 25% behind 2018. However our tonnage numbers are holding up well, just fewer ships which compounds the effect on the fixed cost of the pilotage division financials. Biggest loss has been NYK and Glovis RoRo service and fewer log vessels than anticipated. Loss of RoRo is primarily due to some consolidation in shortsea Mexican trade and Glovis/Nissan business being diverted to Tacoma. Drop in log traffic primarily due to instability of trade policies.

Pilot Boat Replacement Project

The replacement committee met with representatives from Baltic Boats US, Krivchak, and DAMEN. Kahai has been in touch with pilots and administrators from several ports on the coast who have or are going through searches to get their impressions and experience. Randy is working with a consultant that has been used for research in a number of searches who will assist in further refining our operating conditions and evaluate the specific proposals we receive to make sure we are getting consistent information for evaluation. We anticipate narrowing our search in the next couple of weeks down to two of the three manufacturers and will identify the specific boat from each for a direct comparison. We have boats from each of these manufacturers that we can tour and ride on to get a hands-on look. Randy Lewis has collected some information from the engineers for two of the manufacturers related to wave conditions off Grays Harbor that we are going through. He has also been in discussion with the owner of a used pilot boat from Georgia that is similar in design to the Columbia River boats. He has sent detailed information including the most recent marine survey for our review.

Marina Dredging

Hit minor snag in permitting for marina dredging. It appears that Corps regulatory didn't follow their own procedures and failed to consult with the navigation division about in lane disposal causing some additional delays. So it appears that if we screw up our permit application it is our fault and if they screw up their permit process it is still our fault.

Celebrating the industry: Ports **Day 2019**



On April 5th, port authorities throughout the Western Hemisphere will be recognizing and celebrating the port industry's role in job creation and economic development in the communities they serve across the Americas.

In a recently released economic impact report for U.S. coastal ports by Martin Associates, the number of family-sustaining jobs that America's ports support rose from 23.1 million in 2014 to 30.8 million in 2018, with average annual salaries now at \$62,800, up from \$53,723 just five years ago. Canada to Modernize Pilotage Service with New Legislation

- ✓ The inclusion of principles in the Act regarding efficient and cost-effective pilotage services (clause 226):

Canada to Modernize Pilotage Service with New Legislation

The Canadian government is planning to introduce new legislation to modernize Canada's pilotage service for commercial ships. The government has indicated that the amendments will focus on strengthening the governance of pilotage authorities, strengthening enforcement provisions, streamlining fee-setting and increasing transparency.

The Canadian Chamber of Marine Commerce (CMC) welcomed the Federal Budget plan, noting that the system has not been overhauled in 45 years. "Pilotage costs in Canada are out of control and have a long history of increasing at rates that far exceed inflation," said Bruce Burrows, president of the Chamber of Marine Commerce. "This government-mandated service has for decades been provided by monopolistic entities with little accountability or input from ship operators and their customers – despite the fact that it is paid for by industry fees – costs passed ultimately to consumers."

As explained by CMC, with just over 400 pilots in Canada, pilotage is managed by four federal crown corporations, each with their own set of regulations, operational procedures and management practices. CMC added that in many of the pilotage zones, archaic and cumbersome rules make it almost impossible for domestic ship masters and mates to be certified to pilot their own vessels, despite having similar local knowledge and expertise and having access to state-of-the-art navigation and traffic control management systems.

Savannah, Houston drive Asia import shift to East Coast

The ports of Savannah and Houston in 2018 saw the sharpest growth in imports from Asia among the 10 largest US gateways. Throughput of Asian imports expanded 11 percent at Savannah compared to 2017, while Houston's volume surged 19.6 percent, albeit from a smaller base, driving a broader bleed of inbound goods from the West Coast to the East Coast. Savannah's 0.45 percentage point market share gain of East Coast Asian imports contrasts with New York-New Jersey, which lost 0.32 percentage points of market share, and Norfolk, the third-largest East Coast gateway, which lost 0.62 percent percentage points. Nationally, West Coast ports continued to lose market share in the Asia import trade, dropping to 64.2 percent of total US Asian imports from 71.9 percent in 2013. East Coast ports increased market share to 31.3 percent from 25.8 percent, and Gulf Coast ports to 4.1 percent from 1.9 percent in 2013.

Ensenada targets LA-LB cargo with expansion

Amid double-digit volume growth, the port of Ensenada, Mexico, is investing \$100 million to expand its container capacity in an effort to lure cargo normally moving through the Los Angeles-Long Beach port complex 200 miles to the north. Hutchison Group's Ensenada International Terminal (EIT), the port's only container terminal, last month received two new super post-Panamax cranes as part of an upgrade that will increase the facility's container storage area, more than double the length of its 1,000-foot dock, and boost the terminal's annual handling capacity from 300,000 TEU to 400,000 TEU. "We are much closer to the industrial centers than Los Angeles and Long Beach," Hutchison said in a statement. "And we also have an efficient service that can deliver the cargo the same day" to the regional manufacturing sector, the company said.

Global union joins fight against LA terminal automation

The International Longshore and Warehouse Union (ILWU) and the International Transport Workers' Federation (ITF) Tuesday charged that in <u>automating</u> a portion of the APM Terminals Pier 400 facility in Los Angeles, the Maersk affiliate is sacrificing productivity for lower labor costs. Jacqueline Smith, maritime coordinator at the ITF, an intergovernmental agency within the Organisation for Economic Co-operation and Development (OECD), and Dane Jones, ILWU business agent and treasurer, addressed the A.P. Moeller-Maersk general meeting in Copenhagen on the financial and social impacts of automation, including APM's plans to introduce autonomous straddle carrier yard tractors in a 100-acre portion of the 440-acre terminal. A port spokesperson said Tuesday the Los Angeles Harbor Commission, after several <u>delays</u>, is scheduled to decide at its April 16 meeting whether to approve a construction permit needed by APM to move forward with the project.
