The City Council of the City of New Munich met in regular session at 6:30 p.m., in the City Hall. Kurt Thelen, Ron Doll, Jordan Schmiesing, Courtney Fiedler, and Sandy Zierden were present.

On a motion by Sandy Zierden, 2nd by Courtney Fiedler and carried the minutes from April 1, 2024 were approved.

Others present at meeting: Tom and Sasha Newman wants to know what their land on the edge of town is zoned as. Will look into it. When shed was built on it because of the size of the shed it then would have become commercial. Steph Boeckers, Jessica Wolbeck for Liquor License. Jim Hemker with Freeport State Bank.

Fire Chief Al was present–1 medical call. Med Compass will be coming for exams. Still working on the rental inspections. 3 have been scheduled.

Waste/Water Operator Jon was absent. Sent report.

Request(s) for Action:

New impellers on north lift

- I had WW Goetsch give me a quote to help fix the rag issue on North Lift Station, they recommended to take the cheaper route and install new impellers on the pumps we have to see if that helps the issue.
- Cost of \$960.00 per pump (x2) + installation. \$2500 total
- It is perfectly fine if you want to wait until next meeting to further discuss this with me in person.

Public Works Update(s):

- Was suppose to meet with MPCA for an inspection of New Munich's Wastewater tomorrow May 7th but with my back issues Taylor Olson MPCA compliance inspector, kindly rescheduled to May 22nd.
- Had SEH get us on the PPL (project priority list) for new wells and well house. Being we are over our limit on Manganese it should put us high on the priority list for funding.
- Working with Silversmith to get us a quote on a GIS mapping system for our infrastructure. Ballpark estimate is like \$2000 for the system, but I will have concrete numbers for you at the next meeting.
- Consumer Confidence Report will be completed within the next 2 weeks and will post it at city hall and the post office.

Building Permits – 2 building permits. Gerry and Naomi Holdvogt. Expand Driveway on southside with concrete. Replace pebble walkway with concrete from driveway to backyard. Mark and Jessica Wolback/Hot Shots. Replace roof on bar. Add patio on west side. Replace front roof and side roof over doors.

Jim Hemker with Freeport State Bank was present at the meeting to discuss the empty bank lot. Jim and Freeport State Bank would like to donate the land back to the city of New Munich. Was originally purchased from the city. The bank will have is surveyed and some preliminary work if the city is interested in the parcel of land. Waterline was left in when building was taken down. Worms Lumber is also interested in having the corner widened out. Motion was made by Sandy Zierden to graciously

accept the donation of land/parcel where the Freeport Bank Building stood back into the city of New Munich, 2nd by Ron Doll, Motion carried.

120 7th Ave E-Kasten trailer home place. Have residents concerned about condition of property. Kurt is going to try to get in touch with the owner.

Fenced in Dog Kennels-if not more than 16 ft in length no not need a permit. 6 months or less then are considered temporary. Will need to keep an eye on them to see if they are up in 6 months yet.

3rd Ave E-Munich Acres-What is going to be done with the road. For right now going to blade the road and put down class 5 and then lease for about a year. Then will assess and will consider potentially putting asphalt down at that time.

City Street Repairs-Going to look into getting some quotes to see what it will take to fit and patch some of the bad spots on the side streets in town. Potentially do a seal coat.

Culverts in town-Will see if R-Way Pumping would have time to clean them out.

Shooting and leaving the dead animal lay-City does have a no firearm policy in town. Resident will be contacted.

Landscaping city hall-Looking for find someone who would be willing to volunteer their time to do some landscaping around city hall. A 4-H group, boy scouts, or youth group. Contact the city. 320-837-5202
