Discussion of SC Regional Teams Clinic

Sabina presented information for the SC Regional Teams Clinic to be held at Aiken Gymnastics on April 5, 2025 for all Regional SC State Team athletes, including one alternate, for Levels 6, 7, 8, Xcel Gold, Platinum, and Diamond. The purpose of the clinic is to give all SC State Team athletes an opportunity to meet each other and to have time together prior to competing as a team at Regionals. Items presented included the invitation and the rotation plan for the clinic.

Clinic will be free to the athletes and their coaches, and judges will be asked to volunteer their time and will receive in-gym hours. Invitations will be given to the athletes at State Championships, and registration will be through the USA Gymnastics Meet Reservation system, deadline April 2. Val will follow up with coaches who do not register to determine if athletes will be in attendance or not.

As part of the discussion, it was determined to have a separate session at the clinic for the Level 9 and 10 Regional qualifiers, as an opportunity for these athletes to spend time with each other, too.

David made a motion for a Level 9 & 10 session to be added to the SC Regional Teams clinic.

It was discussed to offer Aiken Gymnastics the standard facility fee of \$1,000 for the use of their facility for the clinic.
