1. Article XI, Section 4 is hereby deleted in its entirety and replaced as follows:

<u>Section 4.</u> <u>FENCES.</u> Any fence or wall installed within the Subdivision must meet all requirements of the Zoning Ordinance and must be approved as provided in Article VIII. Nothing in this paragraph shall be deemed to apply to or regulate retaining walls made necessary by the slope or grade of any Lot or Lots nor to any fence installed by the Declarant at any entrance to or along any street within the Subdivision.

Except as specifically amended herein, the Declaration shall remain and continue in full force and effect.
