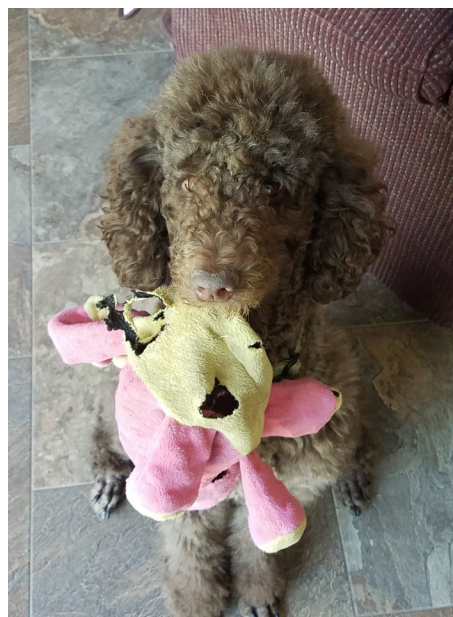

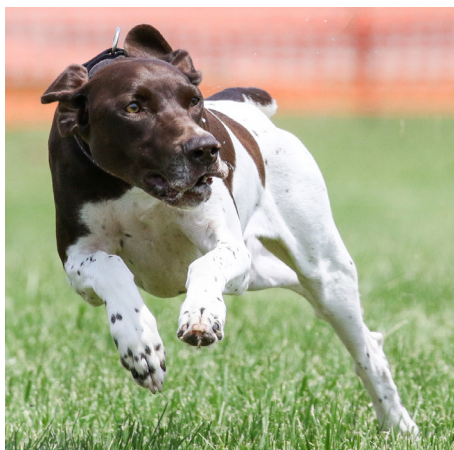

Introduction to Training for Competition

This class is for the owner who may be interested learning the skills necessary to compete in rally or obedience competition.

Admission Criteria

Dogs should have successfully completed a manners class or:

- Dogs should have self-control in a group setting
- Dogs should have a basic understanding of the commands: sit, down, come, and stay.
- Dogs should be under control when walking on leash.

Pre-Novice

The foundation class for the competitive obedience classes. Focus is on prompt, attentive and technically correct response to the obedience commands needed for the beginning competition dog and handler. The Figure Eight exercise is introduced. Tuck sits, fold back downs, the back up, and kick back stands are reviewed or introduced...Recalls off leash are introduced with the correct front position.

Admission Criteria:

- Dogs should be mature and calm enough in a group setting to focus and learn some of the more advanced skills.
- Dogs should be able to respond to their handler's verbal commands to sit, down and come without needing **excessive** physical manipulations.
- Dog can heel with the owner under reasonable control with attention for a short distance (3 to 5 steps)
- All behaviors are performed on leash
- .This class is for the owner interested in rally or obedience competition.

Criteria for Completion of Class

- Dog can perform all the exercises required to qualify in the AKC Beginner Novice class.
- Dog can do a 20 foot recall off leash ,without a finish..
- Dog can do a novice heeling pattern and Figure 8 on leash
- . Dog can do a sit stay with leash attached ,while handler walks a 30 foot large circle around the dog.
- .Dog can do a sit or stand for exam while handler holds the leash 6 feet away from the dog.

Novice

All ring procedures for the AKC Novice Obedience class are practiced. Emphasis is on attention and reliability. Off leash work is introduced. The dumbbell hold is reviewed or introduced. The recall over the jump as performed in the UKC Novice Class is introduced. Tuck sits, the back up, fold back down and kick back stand will continue to be practiced.

Admission Criteria: This is for dogs who have successfully completed Pre-novice or can demonstrate that they can:

- Heel on leash with reasonable attention doing standard heel patterns including change of pace all the turns, and automatic sit at all halts.
- Respond to all commands to sit, down, and come regardless of the position of the handler.
- Maintain a stand stay or sit **on leash** while being examined by another person with minimal foot movement or change in position.
- Maintain a sit stay for 1 minute and down stay for 3 minutes on leash with mild distractions present..

Criteria .for Completion of Class

_Dog will perform exercises as required to qualify in the AKC Novice Class

- Heel on leash with automatic sits.
- Figure 8
- Stand for exam
- Heel free
- Recall with front and finish
- One minute sit stay with leash attached to dog
- Three minute down stay with leash attached to dog

Beginning Open

Foundation exercises for Open are taught, such as the retrieve, jumping, and drop on recall. Out of sight sits and downs are introduced with handlers leaving for a few seconds at a time.

Admission Criteria:

- Must have successfully completed the Novice class or be able to perform the exercises as required to qualify in the AKC Novice Class.
- Dog must be under control off-leash.

Criteria for Completion of Class

- Dog can reliably jump the high jump and the broad jump when called over
- Dog can jump the high jump with dumbbell in mouth when called.
- Dog can do a sit stay holding the dumbbell while handler walks across the ring and then calls the dog.
- Dog can hold dumbbell and release on command.
- Dog can walk with dumbbell in mouth.
- Dog can pick up dumbbell from the floor or a chair
- Dog can pick up dumbbell if thrown a short distance
- Dog can respond to the down command while in motion or standing at least 10 feet from the handler.

Open

All the standard exercises for the Open class are practiced. Emphasis is on reliability regardless of distractions. The standard exercises for the Open class are practiced.

Admission Criteria: . Dog must have successfully completed the Beginning Open class or have instructor's permission. and dog must::

- Reliably do all the Novice exercises off leash.
- Retrieve a thrown dumbbell 5 feet without distractions.
- Do a moving drop without distractions.
- Jump over a high jump holding a dumbbell .
- Jump over a broad jump without distractions.
- Do an out of sight long sit and down for at least 1 minute.

Criteria for completion of Class:

Dog must be able to perform all the exercises as required to qualify in the AKC open class

Beginner Utility Class Criteria

This class introduces the foundation exercises for Utility. Each exercise is broken down into small parts so that the student has a complete understanding of the exercise.. The dog is introduced to articles and gloves. The go out is taught separately from directed jumping. Signals are started at a close distance. The moving stand is taught in two parts..

Admission Criteria The dog must have been taught to jump, introduced to the open exercises, must have a reliable dumbbell retrieve and the handler must have off leash control of the dog.

Utility Class Criteria

All the standard exercises for the Utility class are practiced. Dogs should have some of the utility foundation exercises for entry into this class. Emphasis is on reliability with varying circumstances. The dog must have a reliable retrieve. Training is performed on and off leash with verbal commands and hand signals for the signal exercise which includes heeling, stand, stay down, and recall. The dog is taught to select by scent alone the handler's metal, wood, or leather articles from among other articles. The dog is taught to retrieve one of three gloves and to do a go out across the ring and then jump either a bar jump or high jump indicated by the handler..

Admission Criteria: This is for dogs who have successfully completed ,the Beginner Utility Class, or can demonstrate that they can do all of the Open exercises off leash. Even if unreliable, they should also be able to attempt to do most of the utility exercises without distractions

CLASS CRITERIA FOR NOVICE RALLY

Students should have a Rally Rule Book for the Rally Venue of their choice.

Students must have taken an Obedience class or a Manners class.

Dogs must be able to heel, down, sit and stand.

Be able to execute a relatively good front position.

Know left and right finish.

Leash handling- 4-6 feet depending on dog size.

Students need to be courteous to other students, the instructors and the Judges when competing.

CRITERIA FOR DOGS LEAVING THE NOVICE RALLY CLASS

Passed Achievement match

Introduced to jumping(time constraints)

Team have earned their Novice Rally Title

WHAT TO EXPECT DOG/HANDLER TEAMS TO LEARN IN THIS CLASS

Correct execution of Novice Rally signs.

Introduction to jumping

3 steps forward and back

Difference between pivot and regular turns.

Learn how Rally novice rings are set up and Ring procedure.

Understand about the fine print on entry forms.

WHAT ARE THE TRAINING TOOLS FOR TEACHING THIS CLASS

The Rally rule book

The rally novice signs

Practicing with the same obstacles and signs as in a trial setting.

Instructor demonstrations to improve muscle memory of dog and handlers.

Encourage students Help at Rally runthrus and volunteer to steward at Rally Trials.

WHAT TRAINING TOOLS FOR STUDENTS TO USE AT HOME

Encourage students to work at home (not hours in a training session but minutes)

Give students ideas for their own equipment to practice at home.

Student handouts with Rally information, Rally Websites and Rally DVDS.

OTHER SUGGESTIONS THAT WERE MADE

Increase class times for Rally.

CLASS CRITERIA FOR RALLY ADV/EXCELLENT

Students should have a Rally rule book for the rally venue of their choice.

Students must have passed the Achievement Trial for Novice.

Dog knows how to jump.

Dog can heel off leash.

Students can understand rally course designs.

CRITERIA FOR DOGS AND HANDLERS LEAVING THIS CLASS

Have earned their RAE in AKC and would like to participate in other Rally venues.

WHAT DO YOU EXPECT DOGS AND HANDLERS TO LEARN FROM THIS CLASS

They will learn the proper way of executing the Adv/Ex signs.

Know the difference in the Jump signs-210-Send to jump-103-Send over jump and how to execute them right.

Will learn the backup 3 steps with Dog in heel position.

Learn how to do signs 206 thru 209. New signs that were introduced in 2012 that are similar to the Obedience Utility signs.

Will learn the big difference between pivots and turns.

Will learn Rally ring procedures-Course set up, timing in trials, entering the ring on a loose leash.

Will be courteous to other students, instructors and Judges when competing.

TRAINING TOOLS FOR TEACHING THIS CLASS

The proper equipment to be used in these classes that is used in trials so that students understand what the equipment will look like.

The instructor will do demos on exercises that will help students build muscle memory and body awareness to help students perform the signs to the best of their ability.

TRAINING TOOLS FOR STUDENTS TO WORK WITH AT HOME

Encourage students to work their dog at home not for hours at a time but for minutes.

Watch DVD's on Rally. Lots of websites that can be helpful

and have great information.

Suggestions on how to build equipment so they can practice at home.

Buy a key from the club and train in the building when the want to.
