# **ELECTION OF DIRECTORS**

A Candidacy Disclosure Form was mailed to all current Owners of Records providing each the opportunity to declare their candidacy for three (3) seats on the Board to fill. Two (2) positions for a two (2) year term, and one (1) position for a one (1) year term.

In order to have their name PLACED IN CONTENTION or appear on the secret ballot, the form must have been received at the management office <u>no later than the close of business October</u> **28**, **2024**.

As of the date of this Notice, a Candidacy Disclosure Form has been received from Robert Rosenfeld and Brenda Tierney.

Pursuant to the law concerning election of director procedures contained within NRS 116.31034, the Executive Board determined that if, at the closing of the prescribed period for nominations for membership on the executive board, the number of candidates nominated for membership on the executive board is equal to or less than the number of members to be elected to the executive board at the election, then the secretary or other officer specified in the bylaws of the association will cause notice to be given to each unit's owner informing each unit's owner that: (a) The association will not prepare or mail any ballots to units' owners pursuant to this section and the nominated candidates shall be deemed to be duly elected to the executive board unless: (1) A unit's owner who is qualified to serve on the executive board nominates himself or herself for membership on the executive board by submitting a nomination to the executive board within 30 days after the notice; and (2) The number of units' owners who submit such a nomination causes the number of candidates nominated for membership on the executive board to be greater than the number of members to be elected to the executive board.

Therefore, notice is given informing each unit's owner that the association will not prepare or mail any ballots to units' owners and candidate(s) Robert Rosenfeld and Brenda Tierney shall be deemed to be duly elected to the Executive Board at the November 19, 2024, Annual & Election meeting of the units' owners.
