### Financial Policy

#### Financial Policies:

- IDC Accepts Cash, Checks, Visa, MasterCard, Discover & Amex
  - \$39 fee will be charged for all returned checks
  - \$25 fee will be charged for all declined credit card automatic account payments
- No refunds of any kind will be allowed after 1<sup>st</sup> day of student's scheduled classes
- Student Account credits will only be considered in cases where injury prevents dancer from completing his/her dance season. This credit will not be considered without a medical doctors note - no refunds will be given
- Financial plans/agreements are available as a courtesy to the families of IDC at no additional charge. Payment plans are only available with our automatic payment option. Credit card information will be kept on file and charged each month as per the IDC Financial Agreement. Financial plans can be set up on a monthly basis
  - Monthly payment plans are typically set up using a 9 month payment duration (Sept - May)
  - Payments are due on either the 1<sup>st</sup> or 15<sup>th</sup> of the month
  - The first payment is due at time of registration.
  - If student account is past due for any reason, a \$15 late fee will be assessed on day 5 of delinquency and for each additional month the account remains past due! Student will be excluded from class(es) if account is more than 10 days in arrears until account is brought current.
- All financial agreements between student/parent must be in writing and may only be terminated by written request and will require an advance 30-day written notice wherein parent/guardian is still responsible for any payments that fall within that 30-day period.
