

ORDINANCE NO. 370

AN ORDINANCE REPEALING OR AMENDING ORDINANCE NO. 358 BY CHANGING THE RATES TO BE CHARGED FOR UTILITY SERVICES.

Be it ordained by the governing body of the City of Gaylord, Kansas as follows:

Section 1. RATES. The rates per calendar month for the use of water in the city shall be as follows: \$38.68 for the monthly minimum base rate beginning on October 1st, 2018; all water usage in any one calendar month shall be charged at the rate of \$3.00 per thousand gallons. A minimum monthly rate of \$38.68 shall be paid by each resident having water service provided. All residents of the city who have sewer and/or solid waste services provided shall pay a minimum monthly rate of \$16.84, with this increasing to \$21.84 on January 1st, 2019, and to \$26.84 on March 1st, 2019. The minimum monthly rate for water, sewer, and/or solid waste services for residents of the City of Gaylord, Kansas shall be \$65.52 by March 1st, 2019. Automatic modification of water, sewer and/or solid waste rates, for all users, for water, sewer and/or solid wastes services shall be modified by increasing each rate 3% of the rate then existing, rounded up to the nearest one-tenth of a whole cent, effective for the utility billing on January 1st of each calendar year beginning on January 1st, 2019 unless the governing body, by resolution, determines otherwise.

The rates per calendar month for the use of the water for all customers who reside outside the city limits shall be as follows: \$49.91 for the monthly minimum base rate beginning on October 1st, 2018; all water usage in any one calendar month shall be charged at the rate of \$3.00 per thousand gallons. A minimum monthly rate of \$49.91 shall be paid by each resident having water service provided. All residents outside of the city limits who have sewer and/or solid waste services provided shall pay a minimum monthly rate of \$22.45, with this increasing to \$27.45 on January 1st, 2019, and to \$32.45 on March 1st, 2019. The minimum monthly rate for water, sewer, and/or solid waste services for residents who reside outside of the City of Gaylord, Kansas shall be \$82.36 by March 1st, 2019. Automatic modification of water, sewer and/or solid waste rates, for all users, for water, sewer and/or solid waste services shall be modified by increasing each rate 3% of the rate then existing, rounded up to the nearest one-tenth of a whole cent, effective for the utility billing on January 1st of each calendar year beginning on January 1st, 2019 unless the governing body, by resolution, determines otherwise.

The rates per calendar month to be charged businesses for water service, whether within or outside the city limits shall be as follows: \$38.68 for the monthly minimum base rate beginning on October 1st, 2018; all water usage in any one calendar month shall be charged at the rate of \$3.00 per thousand gallons. A minimum monthly rate of \$38.68 shall be paid by each business having water service provided. All businesses of the city who have sewer and/or solid waste services provided shall pay a minimum monthly rate of \$16.84, with this increasing to \$21.84 on January 1st, 2019, and to \$26.84 on March 1st, 2019. The minimum monthly rate for water, sewer, and/or solid waste services for businesses of the City of Gaylord, Kansas shall be \$65.52 by March 1st, 2019. Automatic modification of water, sewer and/or solid waste rates, for all users, for water, sewer and/or solid waste services shall be modified by increasing each rate 3% of the rate then existing, rounded up to the nearest one-tenth of a whole cent, effective for the utility billing on January 1st of each calendar year beginning on January 1st, 2019 unless the governing body, by resolution, determines otherwise.

The rates to be charged churches shall be as follows: \$20.72 for the calendar monthly minimum base rate beginning on October 1st, 2018; all water usage in any one calendar month shall be charged at the rate of \$3.00 per thousand gallons. A minimum monthly rate of \$20.72 shall be paid by each church having water service provided. The minimum monthly rate for water, sewer, and/or solid waste services for churches of the City of Gaylord, Kansas shall be \$20.72 by March 1st, 2019. Automatic modification of


water, sewer and/or solid waste rates, for all users, for water, sewer and/or solid wastes services shall be modified by increasing each rate 3% of the rate then existing, rounded up to the nearest one-tenth of a whole cent, effective for the utility billing on January 1st of each calendar year beginning on January 1st, 2019 unless the governing body, by resolution, determines otherwise.

All apartment projects or housing projects, will be charged on a per rented unit basis, located within the city shall be charged \$38.68 per rented unit for the calendar monthly minimum base rate beginning on October 1st, 2018; all water usage in any one calendar month shall be charged at the rate of \$3.00 per thousand gallons. A minimum monthly rate of \$38.68 shall be paid by each rented unit within each project having water service provided. All residents of the city who have sewer and/or solid waste services provided shall pay a minimum monthly rate of \$16.84, with this increasing to \$21.84 on January 1st, 2019, and to \$26.84 on March 1st, 2019. The minimum monthly rate for water, sewer, and/or solid waste services for residents of the City of Gaylord, Kansas shall be \$65.52 by March 1st, 2019. Automatic modification of water, sewer and/or solid waste rates, for all users, for water, sewer and/or solid waste services shall be modified by increasing each rate 3% of the rate then existing, rounded up to the nearest one-tenth of a whole cent, effective for the utility billing on January 1st of each calendar year beginning on January 1st, 2019 unless the governing body, by resolution, determines otherwise.

Section 2. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its adoption and publication in the Smith County Pioneer.

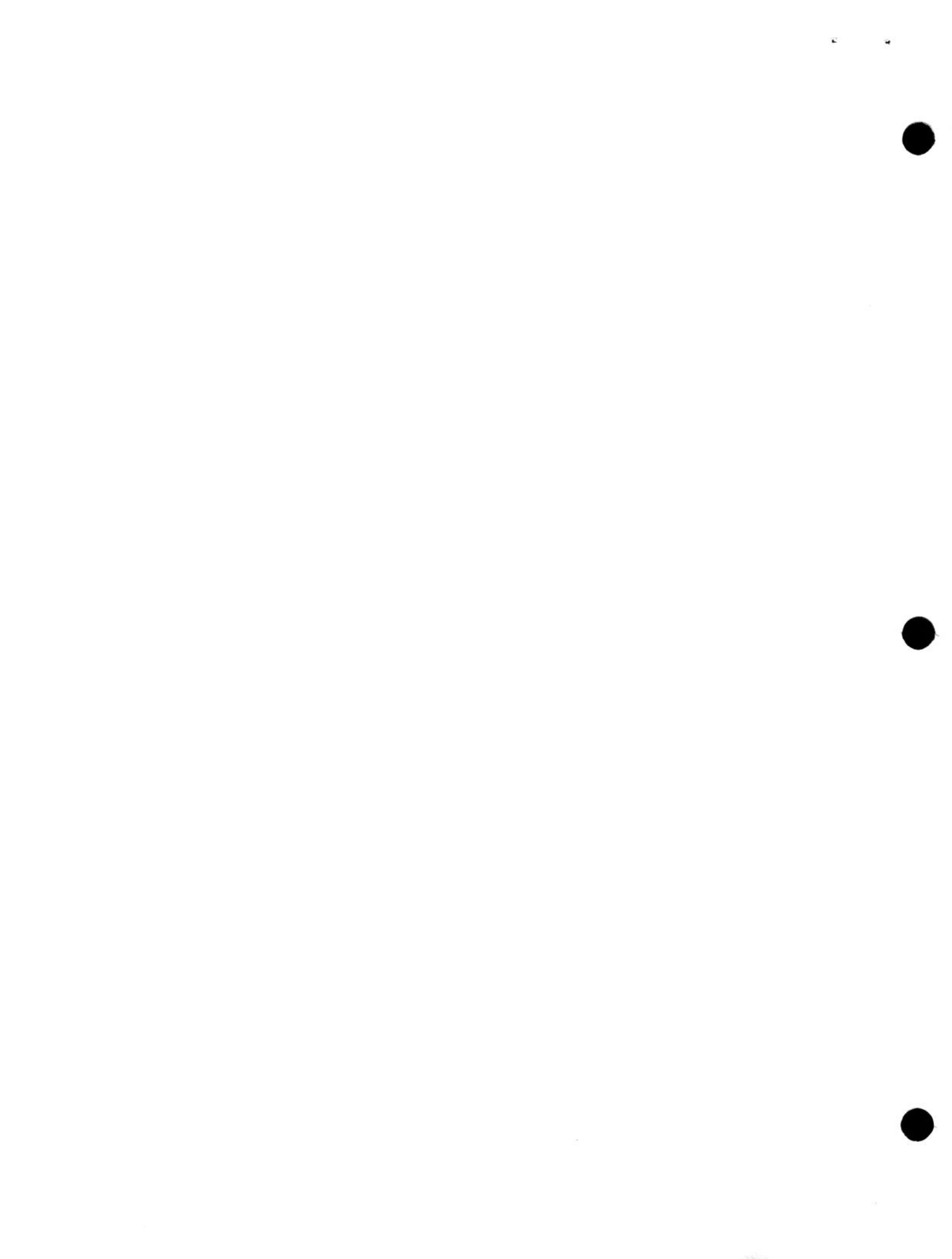
