## REORGANIZATION MEETING MINUTES

## **FEBRUARY 18, 2025**

Chairwoman Napolitani called the reorganization meeting of the Warren County (Pequest River) Municipal Utilities Authority to order at 7:00 P.M. The meeting was held at the Authority's Administration building located at 199 Foul Rift Road, Belvidere, New Jersey.

#### Roll Call:

Laurel Napolitani, Chairwoman Joseph Roth, Vice Chairperson Angelo Accetturo, Treasurer Gerald Norton, Secretary Anne Marie Skoog - Absent

Also, in attendance: Kim Francisco, Authority CFO; Brian Tipton, Esq., Authority Legal Counsel; John Inscho, Executive Director and Susan Wright, Administrative Assistant.

Chairwoman Napolitani led everyone in the Pledge of Allegiance and read the Introductory Statement.

#### REPORTS OF COMMITTEES

Finance Committee: Mr. Accetturo did not have any information to report.

Personnel Committee: Chairwoman Napolitani who chairs the committee, gave a brief synopsis of the Personnel Committee's activity during the past year, such as, the hiring of D. Berger as Operator/Mechanic after B. Walters leaving. Operator M. Berger is working closely with AllMax.

5-Year Capital Improvement Committee: Mr. Roth did not have any information to report.

Chairwoman Napolitani turned the meeting over to Mr. Tipton to conduct the Election of Officers.

#### **ELECTION OF OFFICERS**

Mr. Tipton opened the nominations for Chairperson.

Mr. Roth made a motion to nominate Laurel Napolitani for the Chairperson. Mr. Accetturo seconded. Motion passed unanimously on a roll call vote.

Mr. Tipton turned the meeting back over to Chairwoman Napolitani who opened the nominations for Vice Chairperson, Secretary and Treasurer. Mr. Accetturo made a motion to nominate the current slate with Mr. Roth for Vice Chairperson, Mr. Norton as Secretary and Mr. Accetturo to remain as Treasurer, Mr. Roth seconded. All in favor, motion passed.

#### APPOINTMENT OF OFFICERS

General Counsel: Chairwoman Napolitani presented a resolution to award a non-fair and open contract for professional services to Florio Perrucci Steinhardt Cappelli & Tipton, LLC, for legal services for the upcoming year. The rates are \$190.00 per hour, blended rate, for any attorney in the firm, and \$75.00 per hour for paralegals.

Mr. Accetturo moved to adopt Resolution #25-04, awarding a non-fair and open contract for professional services to Florio Perrucci Steinhardt Cappelli & Tipton, LLC, for legal services from February 18, 2025 to February 17, 2026. Mr. Norton seconded. All in favor, motion passed.

Consulting Engineer: Chairwoman Napolitani presented a resolution authorizing the award of a non-fair and open contract for professional engineering consulting services to CP Engineers, LLC for the upcoming year. Various rates are in the agreement.

Mr. Accetturo moved to adopt Resolution #25-05, awarding a non-fair and open contract for professional engineering consulting services to CP Engineers, from February 18, 2025 to February 17, 2026. Mr. Roth seconded. All in favor, motion passed.

#### APPOINTMENT OF COMMITTEES:

Finance Committee: Mr. Accetturo will remain as Chair and Mr. Norton will serve on the Finance Committee.

Personnel Committee: Chairwoman Napolitani will Chair and Mr. Inscho will serve on the Personnel Committee.

Capital Improvements Committee: Mr. Roth will remain as Chair and Ms. Skoog will serve on the Capital Improvement Committee.

Chairwoman Napolitani introduced a resolution for the appointment of the Authority's Public Agency Compliance Officer for 2026.

Mr. Norton moved to adopt Resolution #25-06, authorizing the appointment of John Inscho as the Authority's Public Agency Compliance Officer (PACO) for 2025. Mr. Accetturo seconded. All in favor, motion passed.

Chairwoman Napolitani introduced resolutions to establish a schedule of meeting dates and designation of the official newspapers.

**WCMUA** Reorg mtg. 2025 Mr. Norton moved, and Mr. Accetturo seconded to adopt Resolutions #25-07 and #25-08, establishing the schedule of meeting dates for 2025, and for designation of the Authority's official newspapers. All in favor, motion passed.

All regular meetings will be held on the third Tuesday of the month, and will start at 7:00 p.m., with the exception of the November 2025 meeting, which will be held on the second Tuesday of that month rather than the third Tuesday, and the December 2025 and February 2026 regular meetings, which will immediately follow the Annual Rate Hearing and Reorganization Meeting that will start at 7:00 p.m.

The Board designated *The Express Times* as the Authority's official newspaper, and with *The Star Ledger*, as the two newspapers to receive notices of meetings.

Mr. Accetturo moved that the Reorganization Meeting be adjourned. All in favor, motion carried. The meeting was adjourned at 7:07 p.m.
