THSC Show Rules

1. Cape Fear Poultry Association show rules are NO.1 and THSC show rules come second. So please take a minute, if not entering the CFPA show, to review their rules before THSC. You may do so by visiting CFPA website at www.capecoypoultryassociation.com
2. Exhibitors may enter into either of the two shows. If entering an Exhibit into the Cooped show then that same Exhibit will not be allowed to enter into the Table Top, vice versa.
i.e. if entering exhibit NO.1234 into the CFPA Cooped show then exhibit NO.1234 will not be allowed to enter the Table Top Show.
This is eliminate cross contamination of the two shows while judging is taking place, in hopes of not interrupting either Shows Judge's.
3. Competition in the Table Top Show is open to Tar Heel Serama Council members and non-members.
4. All entries must be accompanied with payment. (Fees will not be refunded if you do not attend)
5. All entries must have leg bands. If birds do not have a leg band, all entries will receive an NPIP band at the door, in which case this band and number will be used for further identification purposes.
6. Any bird showing evidence of infectious or contagious disease will not be allowed to enter the venue.
*When NPIP tested-If test is positive for Pullorum at the door? The bird will be removed and taken by state agents.
7. All Exhibitors will be responsible for feeding and watering their Birds. THSC and CFPA will not be responsible for Monitoring your exhibits.
8. No persons, other than THSC show officers and judge, shall be allowed to handle exhibits without permission of the owner.
9. The Judge's decision will be final.
10. THSC and CFPA will put forth all efforts to ensure the safety of your exhibits. However, neither will be responsible for the loss or accident to any birds or persons during the show.
- 11."Photographer's Right" By entering birds, you have agreed to allow Tar Heel Serama Council & Cape Fear Poultry Association to use photographs taken by THSC and CFPA photographers or members for the use of advertising/promotion on websites and other publications.
12. Cocks and Hens are birds over 12 months. Cockerels and Pullets are birds under 12 months of age.
13. Exhibitors must be prepared to show when their class is called. Once Tier 2 begins, no other birds will be allowed to show in the first Tier. However, THSC officers and staff will put forth all effort to notify all involved before progressing to the next Tier.
14. **Cooping your exhibits is a requirement.** You may coop them in the night before the event from **5pm-9pm on Dec, 9th,** or the day of the show, **Dec 10th before 8:00am EST.** No further exhibits will be allowed to enter the venue after set time on March 10th.
15. Selling of birds is to take place outside the venue. If selling birds in the parking lot then you are required by State to have a North Carolina Poultry/Ratite Dealer License.
