An Act

For the relief and remedy of Michael Joseph Kearns.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress, as an "essential governmental duty" for the "People of the United States," ex rel, Michael Joseph Kearns, while acting as Agent for the Crown of Great Britain, pursuant to the Definitive Treaty of Peace 1783, and as Trustee of the Bankruptcy for the nation, the United States of America, with the "People of the United States" as the Creditor of the United States of America, its states and their citizens, assembled,

SECTION 1. RELIEF AND REMEDY FOR Michael Joseph Kearns.

The Congress, as Trustee, of the United States of America, under Bankruptcy since 1933, as an "essential governmental duty," acting in a manner to support and enforce a Republican Form of Government, specifically for the "People of the United States," ex rel. Michael Joseph Kearns, a man, created by Nature and Nature's God, currently living on the land of the United States, more specifically, Texas, and pursuant to the Political Determination of Michael Joseph Kearns, and in reliance on the adoption and ratification of the 1776 Declaration of Independence, the 1777 Articles of Confederation, the Definitive Treaty of Peace 1783, (8 stat 80), and the 1787 Constitution of the United States for the United States of America, in his self governing private individual capacity, acting in peace, good faith and good behavior, living on the land of the United States, more specifically, Texas, with the part of Texas wherein Michael Joseph Kearns lives and sojourns,

acknowledged by the signatories to the Definitive Treaty of Peace 1783, (8 stat 80) as being "free, sovereign and independent" and "every part thereof" and not being under the exclusive nor partial legislative jurisdiction of the United States of America, under the 1787 Constitution of the United States for the United States of America, and his powers of sovereignty not specifically delegated therein the said 1787 Constitution of the United States for the United States of America, has established procedures on the private side of the Congress for "private bills/acts".

The Congress has put in place the United States of America Department of State, with its Passport Office with the following Mission Statement:

### **Passports Services Mission Statement**

The Department of State will issue to U.S. citizens secure travel documents while providing the highest level of customer service, professionalism, and integrity.

While this Mission Statement only covers U.S. citizens/"inhabitants of the United States"/subjects of the Crown of Great Britain/slaves, the Mission Statement does not cover any of the "People of the United States", Article III of the Definitive Treaty of Peace, 1783, who are acknowledged "free sovereign and independent" pursuant to the Definitive Treaty of Peace 1783, 8 stat. 80, of which I claim to be of that particular political character, status and allegiance.

At the same time, The United States of America, Department of State, has put forth an "APPLICATION FOR U.S. PASSPORT", DS-11 09-2013, OMB CONTROL NO. 1405-0004, OMB EXPIRATION DATE: 01-31-2017 for the same U.S. citizens/"inhabitants of the United States"/subjects of the Crown of Great Britain/slaves, or NON-CITIZEN NATIONALS, while having no such designation for the "People of the United States" as recognized in Article III of the Definitive Treaty of Peace, 1783.

Michael Joseph Kearns has attempted to communicate with the United States of America Department of State on this very subject and no meaningful response was forthcoming, so, this Private Bill is introduced by Michael Joseph Kearns directly to the Congress, on the private side of the Congress, because the claims of Michael Joseph Kearns are made as one of the "People of the United States" and not as one of the "inhabitants of the United States," as those terms are used in Article III of the Definitive Treaty

of Peace 1783, Article 3, (8 stat 80) as herein stated for the expressed recognition of that certain political character, status and allegiance of one of the "People of the United States", Michael Joseph Kearns, by the Congress of the United States of America.

The Representatives and Senators are those elected Representatives and Senators elected by "inhabitants of the United States" to represent their interests and not for the "People of the United States," ex rel, Michael Joseph Kearns, except to provide "essential governmental duties" to the "People of the United States," ex rel, Michael Joseph Kearns.

Michael Joseph Kearns, is NOT a United States Citizen pursuant to the 14th Amendment to the 1787 Constitution of the United States for the United States of America, but is one of the posterity of the "People of the United States" who "ordain[ed] and establish[ed] th[e] [1787] Constitution of the United States for the United States of America" with it's Preamble, minus it's Amendments, in the exercise of his private fundamental substantive unalienable rights guaranteed therein, specifically his right of freedom of association, brings this Article 4, Section 3, Clause 2 Claim, for Redress of Grievances to the Congress of the United States of America, under the said Constitution, with an exhibit of that right existing in the Article of Amendment Number 1, put forth by the Congress and not the "People of the United States."

## SEC. 2. PROCEDURE.

The Crown of Great Britain, the United States of America and the said United States have acknowledged the right of and the authority to Michael Joseph Kearns to present to the Congress of the United States of America, documentation consisting of recorded verified certified copies of a NOTARIAL VERIFICATION OF ESTABLISHED TRUTH, and DECLARATION OF POLITICAL CHARACTER, STATUS AND ALLEGIANCE for the purpose of completely satisfying the political Branch of the United States of America the truth and veracity of the said political character, status and allegiance of one of the "People of the United States," the man, Michael Joseph Kearns.

The United States of America in Congress assembled is authorized and has a duty pursuant to the 1787 Constitution of the United States for the United States of America "... to pay the debts...of the United States" Article 1, Section 8, and while this claim is not for a monetary value, this claim is for a

moral obligation, and the Congress should feel that moral obligation to pass this Private Bill for the Remedy and Relief of Michael Joseph Kearns.

### SEC. 3. RELIEF AND REMEDY.

While the Political Character and Status of Michael Joseph Kearns, as one of the "People of the United States" has been accepted by some officials, officers, agents and employees of various governments, but because of the failure/refusal of some officers, agents and employees of the United States of America, governmental branches, departments, agencies, and services, as well as any and all non-governmental entities performing a governmental function or a quasi governmental function of the United States of America or any political subdivision thereof, to recognize the political character and status of the man, Michael Joseph Kearns, as politically one of the "People of the United States" and his right to freely associate with like minded people, it is necessary and proper to seek relief and remedy from the top political body in the United States, the United States of America in Congress assembled, by the passage by the United States of America in Congress Assembled, a Private Bill/Act as the remedy for the man, Michael Joseph Kearns, so as to establish a uniform recognition of the said Political Character and Status of the man, Michael Joseph Kearns, as one of the "People of the United States" across the entire spectrum of all levels of government and the attendant officials, officers, agents and employees thereof.

Because of the lack of the United States of America, Department of State, Passport Office, to have in place a manner and means to provide proper identification category for the "People of the United States" and after a determination by the United States of America in Congress assembled, as to the truthfulness of the facts supporting the claim of Michael Joseph Kearns, a procedure will be initiated to have a special office of Ombudsman established to communicate with Michael Joseph Kearns if any additional information, facts or testimony is necessary and proper for the passage of this Private Bill/Act for the benefit and remedy of the man, Michael Joseph Kearns, as one of the "People of the United States."

### SEC. 4. TIME FOR FILING.

Notwithstanding any other time limitation, any suit or claim under this Act shall be timely if filed at any time with the Congress of the United States of America.

SEC. 5. NO CHANGE OF SUBSTANTIVE, FUNDAMENTAL OR UNALIENABLE RIGHTS.

Nothing in this Act shall be construed to create, enlarge, modify or abridge any substantive fundamental or unalienable rights not otherwise enumerated, secured and guaranteed by the 1787 Constitution of the United States for the United States of America and laws of the United States of America, effecting the "People of the United States" resulting from the Declaration of Independence and the Definitive Treaty of Peace 1783 (8 stat 80).

SEC. 6. NO EFFECT ON UNITED STATES CITIZENS.

Nothing in this Act shall be construed to confer additional rights, duties or immunities upon United States Citizens under the 14th Amendment to the 1787 Constitution of the United States for the United States of America.

SEC. 7. NO PRECEDENT FOR FUTURE LEGISLATION.

Nothing in this Act shall constitute a precedent with respect to future legislation, including the provision of private relief bills.

SEC. 8. NO AFFECT ON THE RIGHTS OF OTHER PERSONS OR PEOPLE.

Nothing in this Act shall affect the rights of any other person or man/woman not a citizen of the Several States.

SEC. 9. SENSE OF THE CONGRESS.

It is the Sense of Congress in performing an "essential governmental duty" for the "People of the United States," that the 114th Congress should consider policies regarding the political character and status and legal rights of the "People of the United States," who are private self governing people, who are also NOT United States Citizens under the 14th Amendment to the 1787 Constitution of the United States for the United States of America, nor "inhabitants of the United States", nor subject to the jurisdiction thereof and who have a fundamental and natural right to have the highest political body in the United States, the Congress of the United States of America pass a "private bill" to afford one of the "People of the United States," in this matter, Michael Joseph Kearns, who is of such political character and status as one of the "People of the United States," and recognition of that political character, status and allegiance to fully inform all governmental branches, departments, agencies, and services, as well as any and all non-governmental entities performing a governmental function or a quasi governmental function of the United States of America or any political subdivision thereof, and

The Congress of the United States of America, with the passage of this private bill/act does hereby recognize the political character, status and allegiance of the man Michael Joseph Kearns as one of the "People of the United States" and his right to associate with like minded people of the same political character and status, and respectfully commands all governmental and non governmental, branches, departments, agencies, services, and entities of the United States of America as well as any political subdivisions of the United States of America, and their respective, officials, officers, agents and employees, to give full recognition and authority, to the political character, status and allegiance of the man Michael Joseph Kearns as one of the "People of the United States".
