



## El Tribunal Y El Proceso de la Anulación

El personal del Tribunal trata de ser práctico y eficiente en procesar las peticiones que reciben. Deben seguir ciertos protocolos, y solo pedir cosas que son requeridas. Entendemos que habrán retos para los peticionarios, pero hay ciertas cosas que deben tener para poder avanzar: copias de documentos civiles, la dirección de correo de el/la ex-conyuge, y testigos dispuestos.

El proceso de anulación inicia cuando una persona somete una petición al Tribunal para una declaración de nulidad retando la validez de su matrimonio. La parte que inicia el proceso se conoce como el Demandante; la otra parte se conoce como el Demandado. La Petición es enviada al Tribunal en Savannah, Ga. Cuando todo el papeleo está completo, el párroco o diacono someterá el caso al Tribunal. El Demandado es contactado.

Recopilación de Evidencia. Después de que el Demandado ha sido citado, el caso es movido a la etapa de recopilación de evidencia. Es cuando cuestionarios son enviados a los testigos nombrados y al Demandado.

Decisión de la Conclusión de la Investigación. Ahora El Juez(es) examina la evidencia para determinar si el matrimonio era válido.

Con relación a bodas que ocurren dentro de la Diócesis, cuando las solicitudes son recibidas y las dispensaciones otorgadas, el expediente Pre-Nupcial será devuelto a demandante por medio del Servicio de Correo de Los Estados Unidos.

## ?Qué hacer si una amiga piensa en abortar?



Más mujeres y niñas consideran el aborto de lo que pensamos. Familiares y amigas, nuestras niñeras, compañeras de equipo o de trabajo, casadas o solteras. Incluso si alguien se identifica como pro vida, la impresión de un embarazo inesperado, la devastación de un diagnóstico prenatal adverso, la vergüenza, presiones o temores pueden influir en que considere el aborto.

Si una persona compartiera contigo que está embarazada y no ha descartado tener un aborto, ¿sabrías responder? La respuesta está en el viejo adagio: Tenemos dos oídos y una boca, y debemos usarlos en esa proporción.

Aunque el impulso inicial puede ser convencerla de que el aborto termina con la vida de un bebé, eso no es lo primero que ella necesita escuchar. Estudios muestran que muchas mujeres que pasan por esto piensan: "Es el final de mi vida tal como la conozco". Lo que tu amiga necesita saber es que tú te preocupas por ella y que no está sola.

Escuchar primero a tu amiga ayudará a crear confianza y facilitar la apertura. Cuando sepas que realmente te preocupas por ella y confíe en ti, podrás compartir la verdad en el amor y después compartir hechos sobre el aborto, hacerle ver a tu amiga su propia valía intrínseca, y la ayuda y apoyo práctico disponible para que pueda elegir la vida para ella y su bebé.

Cuando una mujer enfrenta un embarazo difícil, la reacción de la primera persona a la que se lo dice suele influir en su toma de decisiones. ¿Cómo respondemos a nuestra amiga de una manera amorosa que exprese la afirmación de la vida para ella y su bebé?

Considere estos cuatro pasos del enfoque L.O.V.E. Approach™\*: Listen and Learn (Escuchar y conocer), Opciones abiertas, Visión y valor y Extender y empoderar.

## Bishops: October is Respect Life Month

Promoting life includes opposing the culture of death's efforts to assist with suicide.

"The deadly and dangerous practice of assisted suicide is now legal in five states (Oregon, Washington, Vermont, California, and Colorado) and the District of Columbia, our nation's capital. With new momentum and lots of money, assisted suicide proponents are pursuing an aggressive nationwide campaign to advance their agenda through legislation, ballot measures, litigation, and public advertising, targeting states they see as most susceptible to their message." Below are two of the many reasons for opposing assisted suicide.

**Broad Definition of Terminal Illness.** Assisted suicide laws typically appear to limit eligibility to terminally ill patients who are expected to die within 6 months but don't distinguish between persons who will die within 6 months with treatment and those who will die within 6 months without treatment. This means that patients with treatable diseases (like diabetes or chronic respiratory or cardiac disease) and patients with disabilities requiring ventilator support are all eligible for lethal drugs because they would die within 6 months without the treatment they would normally receive.

**Puts Vulnerable Persons at Risk of Abuse and Coercion** Once lethal drugs have been prescribed, assisted suicide laws have no requirements for assessing the patient's consent, competency, or voluntariness. Who would know if the drugs are freely taken since there is no supervision or tracking of the drugs once they leave the pharmacy and no witnesses are required at the time of death? Despite a reporting system designed to conceal rather than detect abuses, reports of undue influence have nonetheless surfaced...Elder abuse is considered a major health problem in the United States, with federal estimates that one in ten elder persons are abused. Placing lethal drugs into the hands of abusers generates an additional major risk to elder persons. Assisted suicide laws often allow 1 of the 2 witnesses to the request for lethal drugs to be an heir to the patient's estate. Therefore, an heir or friends of the heir can encourage or pressure the patient to request lethal drugs and then be a witness to the request.

Are You VIRTUS Trained? VIRTUS is a program encouraged by Bishops nation-wide to train adults, clergy included, on promoting safe environment for children and youth. The next VIRTUS training class in our area in English takes place at St. Teresa Church in Albany October 21st from 9:00am to 12:00pm.




This training is required for Safe Environment Compliance for any adult who will come into contact with youth as part of their ministry (a listing of those ministries can be found at <http://bit.ly/1yU4Yk6>), and must be completed before they begin ministry.

We also invite adults who are not currently volunteers to attend this training to learn tools they can use to help keep children safe. 
