## Executive Board Minutes

May 12, 2025

The meeting was called to order at 4:20pm by Karen Bloom.

### I. President's Report - Karen Bloom

#### A. Teacher Appreciation

As Teacher Appreciation Week concludes, I want to express my deepest gratitude to each of you for your unwavering dedication and tireless efforts. Your commitment to our students and communities is the cornerstone of our profession, and your impact is immeasurable. Thank you for all that you do.

#### B. Long Beach Board of Education

The Long Beach Board of Education voted on April 23rd, for the proposed 2025-26 School Budget, and it passed unanimously. If you would like to see the budget presentation, [click here](#). Additionally, if you would like to see more of the details, [click here](#) to see the line by line budget. The Board will put the budget up for a vote to the community on Tuesday, May 20th, 2025. In addition, there will be a Proposition on the back to vote on, to add some unused funds to our Capital Reserves in order to complete some projects next year. The community will have the opportunity to vote on the Budget, Prop 2 and one School Board Trustee position. We urge you to go out and vote yes on the budget.

#### C. NYSUT RA & Presidents Conference

I attended the Presidents conference prior to the RA and was able to attend sessions on The Future of Healthcare, Negotiating Paid Parental Leaves, New APPR Plans and we got an Update from the State Education Department. In addition, Patty Van Loon joined me at the RA, where we gathered with almost 2,000 delegates in order to discuss and vote on the many resolutions that were brought forward this year. I'm happy to report that the resolutions we supported, all passed, as did just about all other resolutions brought to the floor. We also got to hear speeches from the many Union leaders across the State, who were all there to support NYSUT and our causes.

#### D. LBCTA Scholarship Winners

#### **E. LITBF Scholarship Winner**

We are pleased to announce that the selection process for the 2025 Long Island Teachers Benevolent Fund awards has been completed. LITBF sent us the names of the winners; congratulations to Matthew Hartmann and Lana Landa who were both recipients of this scholarship.

#### **F. Packing and Unpacking**

Teachers who are moving and/or packing due to an alternative use of their room or a room transfer shall be paid \$27.29 per hour, up to a maximum of 4 hours. The work must be done outside of the school day and a record kept of the dates and times.

#### **G. Pay Options**

Each year you have three pay options:

- 21(.5) equal bi-weekly payments (September through June)
- 25 payments; 21 payments (September through June) + 4 payments on the last day of school
- 26 payments; you will receive 1/26 of your annual salary every two weeks from the first pay date in September through the last pay date in June when you will receive the remaining paychecks as separate checks, all dated June 30, which you may deposit at any time from June to August. Direct deposit will not be available for the last six paychecks. All deductions will be spread out over the 26 paychecks.

To elect an option other than the one you currently have, you must enroll prior to June 30 and the new option may not be changed until the start of the following school year. The new form will be available soon.

#### **H. Negotiations: School Visits - *Reminder***

As part of our ongoing efforts to keep the lines of communication open, I will be visiting faculty rooms during lunch periods to engage with teachers directly. During these visits, I will be discussing the upcoming contract negotiations and taking the time to listen to any concerns or feedback our teachers may have. This will be an important opportunity for faculty to voice their opinions, and for me to ensure their perspectives are considered as we move forward. I believe these informal discussions will foster stronger relationships, and help address any issues or questions that may arise as we prepare for negotiations. I coordinated dates with the senior reps in each building, and will be there from 11-1 in faculty rooms or other areas where people eat lunch and congregate! Look for an email from your Senior Rep with details! Looking forward to some good chats! Thank you to all the buildings that I have visited so far! I truly appreciate the openness and honesty in our conversations.

**N. NYS Paid Sick Leave - *It is still in effect, until July 31, 2025 - Reminder***

Should you need to quarantine for a positive COVID case you still have access to the NYS Paid Sick Leave. You can only access this benefit three times, and if you used it in years past it does not reset. Once someone uses Paid Covid Leave three times, that person is no longer eligible. Please remember this can only be used for lab confirmed positive cases, and that you should notify HR once positive. The State benefit is not for your child's quarantine or positive case. The COVID Leave Form is located in your main office and can be completed once you return to work.

**O. Annual Turn-In of Sick Days - *Reminder***

If you have accumulated at least 75 sick days and wish to exercise your option of selling back unused sick days earned this year (up to 12 or 14 if you worked at Summer School or Extended School Year) you must submit a "[Request for Payment in Exchange for Accumulated Unused Sick Days](#)" form to the HR Department. The teacher must not have been absent more than 6 days during the school year for which he/she shall claim eligibility for this payment.

**D. Political Action Committee - Jennifer Garrett**

1. **BOE Elections and Budget Season are Here!** Despite the many financial challenges facing our district and others, the proposed 2025-26 district budget reflects a responsible plan with a tax levy increase of 2.40%, which remains within the district's allowable cap.

This budget preserves all existing programs and even introduces new opportunities in areas such as technology, athletics, and extracurricular activities—all while addressing the significant rise in transportation costs.

Also on the ballot is Proposition 2, which seeks voter approval for the district to utilize approximately \$2.9 million from the capital reserve fund to complete essential capital improvements at the high school. **Approval of this proposition would have no additional tax impact on residents.**

As in previous years, PAC will endorse this year's school budget through a postcard mailing, continuing to reach an expanded target audience. This design will also be featured in a social media post, which will be shared via the LBCTA social media accounts. Please feel free to share the image once posted to help amplify our message. Also, in partnership with the Public Relations Committee, PAC will also place an ad in the Herald. These strategies have been successfully implemented in past campaigns and received positive community feedback.

Additionally, the LBCTA Newsletter will be mailed to all NYSUT members residing in the 11561 zip code. This edition highlights just a few of the many exciting events and fundraising successes we've achieved throughout the year. Thank you to everyone who contributed ideas for the newsletter—your input was greatly appreciated.

## **II. Executive Vice President's Report - Amy Leder**

### **A. APPR (Annual Professional Performance Review)**

1. The state has released APPR guidelines that went into effect March 26, 2025. We will continue adhering to our agreed-upon plan for this year. Discussions with administration about future plans will also continue.
2. Feel free to contact me if you have specific concerns regarding APPR.

### **B. Health and Safety**

1. Thank you, Mr. DeVito and Mr. Kramer, for organizing an in-person meeting to review all air quality testing with JC Broderick. All building walk-throughs and air quality assessments have now been completed, and there are currently no concerns to report. Please continue to notify your head custodian if you notice any ceiling tiles that require replacement. As a reminder, ensure that air ducts remain unobstructed-do not place boxes or school supplies high on shelves where they could block airflow into the room. We also discussed the recommendation and the importance of ongoing monitoring of the HVAC systems, regularly replacing filters and ceiling tiles as needed, and continuing to clean dusty areas as much as possible in each building.
2. Air quality reports are available in your principal's office if you wish to review them. If you have any specific questions, please feel free to contact me.
3. We had the last Health and Safety meeting of the year. The agenda centered on district wide safety plan updates. Mr. DeVito detailed classroom temperature management protocols, specifying that students should be relocated if temperatures surpass 88 degrees, and that functional fans are required when temperatures reach 82 degrees.
4. Mr. DeVito also reported on the Workplace Violence Prevention Program, sharing positive feedback and noting that incident reports will be reviewed before the end of the school year.
5. As a reminder, please refer to Mr. DeVito's email on April 23rd that provided you with a copy of the workplace violence form and information on how to find it on the school webpage. You should have also received an email from "[support@gcntraining.com](mailto:support@gcntraining.com)" titled Workplace Violence Prevention Module. Please make sure you complete the Workplace Violence Prevention training on GCN as soon as possible but no later than May 23, 2025. This is a MANDATORY module for ALL employees.

6. Mr. Harvey described the testing of the 911 emergency system to ensure compliance with CARES law, including the implementation of direct dialing and coordination with local dispatch centers. Mr. Kramer updated the group on RAVE panic button testing, confirming successful trials and plans for additional evaluations.
7. There was a discussion about the new New York State cell phone policy. Some possible solutions were discussed such as using Yondr pouches. It was proposed to form a committee to further examine the cell phone policy.
8. Staff members are encouraged to report any unresolved Health & Safety issues at the building level.

# LET MEMBER BENEFITS HELP YOU PLAN FOR RETIREMENT

If you recently retired or plan to do so in the near future, it's important to prepare for the transition from in-service work to retirement.

**Maintaining NYSUT membership in retirement is crucial, especially if you're currently participating in a NYSUT Member Benefits-endorsed program(s) and would like to continue doing so. This can be accomplished in one of two ways:**

- 1** Continue membership within your local if retiree membership is offered. Contact your local to find out if any retiree membership requirements are in place. You must comply with these requirements to continue your membership in NYSUT along with the American Federation of Teachers (AFT) and National Education Association (NEA).
- 2** Continue as an at-large member of NYSUT through the Retiree Council in your region. Contact your local to ensure you will be reported as retired to NYSUT. This will provide you with membership in the Retiree Council in your region along with NYSUT, AFT, and NEA. If you have questions about maintaining NYSUT membership or would like more information about NYSUT retiree programs, you will want to contact the NYSUT Retiree Services Consultant serving your region.
