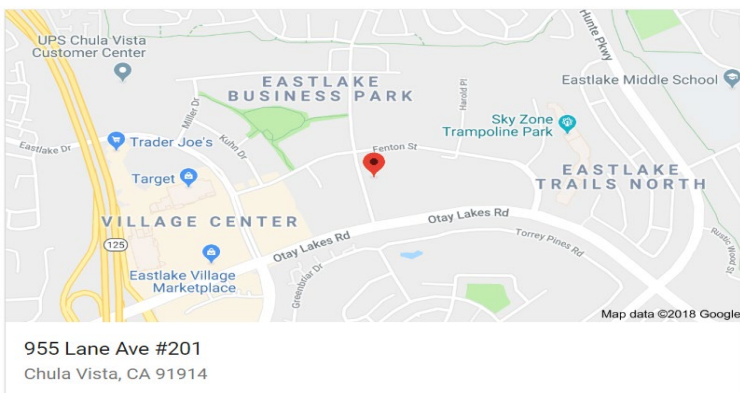
Manual Orthopedic Physical Therapy's (MOPT)
