Courses

All levels will run on a single course with a bird field. All tests will be walked, and only officials may use ATVs. Judges are in charge of the running on the course. The instructions, decisions, and scores of the judges are final.

Dogs

In accordance with AKC Rules, Chap. 1 Sec. 16, all dogs must be on leash at all times, except when actually being tested. Bitches in season shall not be eligible for entry and shall not be allowed on the grounds.

Attire

All handlers, judges, workers, and gallery members must be attired in an article of blaze orange while on the ACBD Club grounds.

Birds

Quail, Chukars, Pheasant, and/or Pigeons will be released for all test levels. Ducks may be used in the Water Test.

Handlers

Handlers are expected to fire a blank pistol at the appropriate time during the testing of their dog. Pistols used must be incapable of firing live rounds. The GSPCI is not responsible for providing blank pistols.

Prizes

Standard AKC Rosettes will be awarded to all dogs receiving a qualifying score.

Scratch Policy

A full refund will be issued if a dog is scratched prior to the drawings. After the drawings are held, a full refund will be issued only for bitches in season, injury, illness, or death. A veterinarian's statement (Chap. 1 Sec. 5) must be submitted to the Hunt Test Secretary within 10 business days after the event in order to receive a full refund.

Grounds

The GSPCI appreciates your help in keeping the grounds clean. Please pick up after your dogs and place all trash in receptacles. Park all vehicles in the designated parking areas. Only hunt test worker's vehicles are allowed near the bird field.

Meals

The GSPCI & GIBC will be providing a hot breakfast and coffee, and cookout style lunch both days. Saturday evening a pizza dinner will be held at the grounds at the close of the day's testing.
