# Presidents' Message

Dear Fellow Brandeis Members,

As we live in this new world of sheltering, cooking, cleaning (done with that), playing games online and Zoom, we wonder when life will return to the "normal life" to which we are accustomed. A couple of months ago, during Genocide week, we joined a Zoom call where a wonderful woman spoke about her experiences as a Holocaust survivor. It was affiliated with Scottsdale Community College and after listening to her describe the first 10 years of her life and the atrocities she lived through, one of the students wrote a question: How do you compare what we are living through now – the Pandemic with the Holocaust? She was stunned by the question and thought for a couple of minutes before she answered. Her answer gave us the perspective that we hope that by sharing, will do the same for you. She said, "There is no comparison. I live in my lovely home, with all the food and drink that I could ever need, lovely clothes, more technology than I can ever use. I can go for a walk outdoors, even in this hot weather and I can be with my family or at least communicate with them by phone or Zoom. There is no comparison. I didn't have any of that. We didn't have enough food or water and lost our homes and families." Her perspective has given us a totally different take on this Pandemic this too will pass and we will be together again, doing whatever it is that makes us happy. So, please, consider this and put life in perspective – it'll help you through this crazy time – know that this will pass and we will be able to resume our "normal life," as long as we take care of our health and the health of those around us.

Virtual programming or Zoom has opened up a whole new world to us – we can see our family and friends whenever we want. We can have fun playing games online with people, join in all of the Summer Camp activities that have been offered and look forward to our incredible Study Groups and programs in the Fall. So many people are volunteering their time to make these things happen. 


# **BNC Award For Phoenix Chapter**


# **Fundraising Programs Committee**

# Meet Our 2020 -2021 Executive Vice Presidents



Leith Baletin Leith was born and grew up in Hillside, a small industrial town just south of Newark, NJ. He "re-met" his wife at their 35<sup>th</sup> high school reunion in 1995. Judy and Leith had had one date when they were juniors, and they celebrated their 20<sup>th</sup> wedding anniversary in May.

Leith received his Bachelor of Electrical Engineering in 1965 from the School of Engineering and Science at New York University's campus in Bronx, NY. In 1968 he studied Engineering Management and graduated from the New Jersey Institute of Technology with a Master of Science degree.

Upon graduation from NYU, Leith began a 30-year career in the Bell System as an engineer and manager in the Northeast Regional HQ of Western Electric Co (a subsidiary of AT&T), later known as AT&T Network Systems. When Leith retired in 1985, he had held various levels of responsibility as an engineering manager. Organizations reported to him in both New Jersey and Maryland at the same time, so he spent many hours on Amtrak's Metroliner.

After retirement, Leith served on his HOA's Board in Wall, New Jersey. He is currently in his tenth year on his HOA Board in Scottsdale and became President in January of this year.

Leith has been a member of the Phoenix Chapter of Brandeis National Committee for nine years. He joined the Board as the liaison for the Men of Brandeis study group, which he has facilitated since 2013. In 2015 he was elected Co-Vice President of Membership and held that position until March 2020.

Leith and Judy have two homes in Arizona. The Scottsdale home has been Judy's since the mid 90's and they also have a home in Prescott Valley. Judy has three grandchildren.



Ellen Widoff Originally from the north side of Chicago, Ellen met her husband Joe during graduate school at the U. of Wisconsin and they spent much of their adult life in the Washington D.C. metro area and later Norfolk, VA. She received additional degrees from the U. of Illinois at Chicago and the U. of Maryland.

Ellen's lifelong commitment to Social Justice and her deep connection with vulnerable and marginal populations was informed by her mother's death when Ellen was two years old, as a result of complications during the birth of her younger brother. The United States still has the highest rate of maternal mortality than any other developed country, and it is the only country where the mortality rate has been rising.

In the early 70's Ellen worked with Eunice Shriver on the Special Olympics and taught at The Joseph P. Kennedy Jr. Institute in Washington, DC.

As Director of The Arc of Montgomery County, Maryland she is most proud of acquiring funding, building and administering the State's first totally accessible Child Care Center for Children with and without Disabilities, their first Child Care Center for Children with Chronic Medical Conditions, and their first After School Program in collaboration with the Boys and Girls Clubs for teenagers with autism and other developmental disabilities.

After moving to Norfolk, Ellen became CEO of Habitat for Humanity where she coordinated the first "48 hour house blitz build" at the Virginia Beach Home and Garden show.

Her volunteer leadership includes President of the Maryland National Organization for Women, President of the Maryland Committee for Children, Board Member of the Norfolk YWCA, the Norfolk JCC, NCJW, AZ, and mentor for the Women's Leadership Institute In addition, she was awarded the State of Maryland's Governor's Citation for 'the development and administration of quality innovative programs for persons with developmental disabilities and their families.' She was recently appointed by Mayor Gallego as a Commissioner on the Phoenix Human Relations Commission.

Ellen and her husband Joe have lived in north Phoenix for the last 10 years and have two sons (Seth and David), two daughters-in-law (Carolyn and Dayna) and a granddaughter (Emily). She enjoys cycling, hiking, and learning from her favorite grandchild.

# What's really making the NFL's Washington team change its name?

For now, they are the professional sports team that must not be named.

But in the near future, the National Football League's Washington franchise, who are currently known by a name that is offensive to Native Americans as well as many others, will drop their racist moniker and adopt a new identity.

Team owner Dan Snyder resisted a name change for years despite widespread protests from many inside and outside football fandom. The reversal was announced only after a series of corporate sponsors threatened in July to end their relationship with the team.

Heller School for Social Policy and Management senior lecturer Michael Appell, an expert in corporate social responsibility who spent 20 years in the footwear industry working with business leaders, is disappointed that it's taken so long for the Washington team to adopt a new name.

He also believes the franchise and other institutions in similar positions have a lot to gain by embracing the spirit of protesters and activists making their voices heard. *BrandeisNOW* discussed with Appell the Washington situation and the role corporate social responsibility can play in impacting profits.

# BrandeisNOW: Why is Dan Snyder changing his team's name only now?

Appell: I don't think they did it because fans have been up in arms or because of this unique, historic moment we've seen with nationwide protests. This was driven by the needs of corporate America. Five of Washington's big sponsors — Pepsi, Walmart, FedEx, Nike and Amazon — exercised their clout by speaking out against the team's name. This was also a way for them to mitigate risk and protect their brand's reputation.

BrandeisNOW: Big brands are increasingly speaking up on social issues, but is there any substance to withdrawing sponsorship or is it just PR for them?

Appell: Speaking out is definitely a trend and in many cases it's superficial. It's easy for companies to back LGBTQ rights and say they believe Black Lives Matter on social media and TV commercials. The hard work is something many haven't done, and it includes hiring and promoting people of color in their companies and putting in place an operational plan that goes beyond PR needs.

These companies feel consumers want to believe their favorite brands understand this historic moment. But they're also counting on the consumer to not look below the surface and see what's really going on once the moment passes.

# BrandeisNOW: What's the difference between investing in clever PR and investing in corporate responsibility?

Appell: A lot of corporations make millions or billions of dollars and find it convenient to fund volunteer or philanthropy programs. That's not corporate social responsibility, which is about creating programs that respond to social and environmental problems, as well as responding to the financial bottom line. I believe there's shared value in these two endeavors. You can address these problems while contributing to profits.

A great example is General Electric and their Ecomagination venture. It's a multibillion dollar division focused on improving the environment through solar and wind power products, hybrid vehicles and fuel- efficient jet engines. And it's

very profitable for GE.

#### BrandeisNOW: How would you advise the Washington NFL team to incorporate social responsibility into their work?


**Appell**: If I were advising Washington I'd say make lemonade out of this lemon. This is a chance to begin anew. Frame it as a new start for the team. If ownership doesn't see this crisis as an opportunity, they should.

That's not to say there aren't risks. If the team loses a lot of games, people will associate the new name with a losing team. You have to produce results. It's not just about an image. You have to produce at some point, too.

# BrandeisNOW: Where does this leave other professional sports teams and organizations with questionable brand identities?

**Appell**: We're going through a major cultural transition, but I worry teams will be resistant to change and won't embrace social responsibility because they feel they're OK with their sponsors.

Consumers have tremendous power and don't exercise it. It's easy for companies to say they support cultural changes because they believe it might help distract consumers from what really matters. There's really no strong consumer movement in America to educate people on how to be social justice consumers. It's a big failure of the social justice movement in America. And without a consumer movement, more companies will themselves accrue more and more power.



The Brandeis National Committee has existed to support Brandeis University in fulfilling its founding principles of access, inclusivity, and tolerance since 1948. # Will this funding...

### ◆ - digitize every one of these collections?

No. This is a multiyear effort that will require ongoing funding to support the work. This campaign is an effort to kick-start the project.

### ◆ - digitize every piece of a collection?

Not everything in the collection can be digitized. There are copyright and donor restrictions that need to be considered.

### ♦ Who decides what pieces of each collection will be digitized?

The Archives & Special Collections department will determine the most beneficial pieces to digitize, partly based on the impact, research demand, and copyright and donor restrictions.

### Can I select a particular collection to digitize?

Please see the giving tiers page. Donors who give over \$2500 will have their name on the page of the collection of their choice, although the Archives & Special Collections will decide how to prioritize digitizing the materials.

### Will all of this material be made publicly available?

No, because of copyright restrictions and donor restrictions, some can be made public, other parts of the collection will be for restricted in-library use only, and some may not be digitizable at all.

### ♦ Will all of this material be made available right away?

Digitization is time consuming, but a project plan will be put into place with a timeline.

### Will you put all of this online?

Because of copyright restrictions and donor agreements, not all content can be made publicly available, and some is not even allowed to be digitized at this time.

## ♦ How will people find it once it's online?

It will be stored in our new institutional repository and discoverable through the library's web interface "OneSearch" as well as through federated search systems like WorldCat.

### ◆ Are you going to create a resource like the Civil War Letters project with these collections?

No. We will make the content available to scholars to do that kind of digital scholarship.

Most of the items in these collections can be digitized, but not everything that's digitized can be available to the public. Some will have to be available only in the library because of copyright and donor agreements. But people who come in can use the digitized version, thereby preserving the original artifact. Because the original is so impactful, we would open the archive as we always have because we serve the entire world with our resources.
