SharpShooters USA Club
Membership Terms and Conditions

- 1.) SharpShooters USA Club is a private membership club which is wholly owned by SharpShooters USA. Acceptance for membership in SharpShooters USA Club does not confer on the holder any membership, rights, or ownership interest in SharpShooters USA. SharpShooters USA Club facilities are available for use by all SharpShooters USA Club Members, guests of members, private citizen groups and by the general public. SharpShooters USA Club memberships are available to provide preferred access, discounts for merchandise, services and facility use, and other benefits to SharpShooters USA Club members. SharpShooters USA Club membership is subject to the membership terms and conditions stated herein. Membership will be granted, and may be revoked, at the sole discretion of SharpShooters USA Club.
- 2.) As part of the consideration for membership, the member hereby agrees to remain a Member and pay the monthly membership dues for a period of not less than one (1) year from the date of this Agreement. SharpShooters USA is entitled to recover its costs, including reasonable attorneys' fees, incurred in collecting sums due to SharpShooters USA under this or any other membership provision or otherwise.
- 3.) All Memberships are subject to payment of a one-time non-refundable initiation fee and timely payment of monthly membership dues. The initiation fee and monthly membership dues for each level of membership vary based on the level of membership purchased, special SharpShooters USA Club promotions and membership availability. Membership dues and benefits may be reviewed and adjusted by SharpShooters USA at any time.
- 4.) Members may select one of the following methods of payment for their monthly membership dues: Automatic monthly or annual credit/debit payment from a VISA, MasterCard, American Express, or Discover Cards. A \$20 fee may be assessed for any automatic debit that is rejected for insufficient funds or any failed credit charge.
- 5.) All members, guests, and other SharpShooters USA Club facility users must follow all SharpShooters USA Safety Standards and Range Rules, and must read, and agree to the terms of the SharpShooters USA Waiver Of Liability, Release Of Claims, and Agreement To Hold Harmless, Defend, And Indemnify which is incorporated by reference into the SharpShooters USA Club Terms and Conditions of Membership. All first-time members, guests, and other SharpShooters USA facility users also must participate in the SharpShooters USA Club range orientation and watch the SharpShooters USA Club safety video before shooting at the range.

- 6.) All guests must be accompanied by a member to be admitted to the firing line. Members are responsible for all actions taken by their guests and will hold SharpShooters USA harmless for property damage, accidents and injuries to or caused by guests.
- 7.) All members and guests are subject to the general policies and rules of operation and administration of SharpShooters USA Club, all of which are intended to provide a safe, professional, friendly, and family-oriented club.
- 8.) SharpShooters USA Club may terminate a membership unilaterally if, in SharpShooters USA's sole discretion, a member's conduct presents a safety hazard to the member or to any other user or SharpShooters USA Club employee or to SharpShooters USA Club facilities. In the event SharpShooters USA Club terminates a membership during the first year of membership, the unused portion of the member's initiation fee will be refunded on a pro-rated basis over the first 12 months of membership for the unused months of the first year's membership. For purposes of this paragraph, a "month" shall include any part of a month. For example, if a membership is unilaterally terminated by SharpShooters USA Club anytime in the first month, the member would receive a refund of ½ of the initiation fee. After 12 months of membership, no portion of the initiation fee will be refunded in any manner. In no event will there be any refund of any monthly membership dues paid. Other than unilateral membership termination by SharpShooters USA Club during the first 12 months of membership, the initiation fee is non-refundable.
- 9.) Any member or guest of a member may be suspended or expelled from the range and/or facility for violation of the Range Safety Rules or for behavior deemed unsafe by SharpShooters USA Club personnel. Decisions of SharpShooters USA Club regarding suspension or expulsion are final.
- 10.) If a member or a member's family members or guest(s) causes any damage to SharpShooters USA Club property, whether accidental, negligent, willful or otherwise, the member, their family members, and/or the member's guest will be removed from the range and/or facility and suspended or terminated from membership. The individual responsible for the damage may be civilly liable or criminally prosecuted. SharpShooters USA reserves the right to charge the member the costs for any such damage, regardless of whether the damage is caused by the member or the member's guest. Should court action be required to collect the damages, the Member will also be liable for SharpShooters USA Club attorney's fees.
- 11.) All SharpShooters USA Club members will be photographed for SharpShooters USA records and identification, and all Members must present their SharpShooters USA Club Identification cards whenever they use SharpShooters USA Club facilities. All guests must present a photo ID before using SharpShooters Club facilities.



- 12.) SharpShooters USA Club Membership may not be transferred or sold.
- 13.) Membership in SharpShooters USA Club will be available only to persons who are legally able to possess a firearm. SharpShooters USA Club members must be in compliance with all federal, state and local laws concerning ownership and the handling of firearms. Membership will be granted, and may also be revoked, at the sole discretion of SharpShooters USA.

I certify as follows: (1) that I am not and have never been the subject of a criminal or any other proceeding that prevents me from legally owning, handling or possessing firearms under Federal, State, and local laws; (2) that I can lawfully own, handle and possess a firearm; and, (3) that all information given in this Membership Application is true and correct to the best of my knowledge.

I have read, understand, and agree to comply with these Terms and Conditions as well as the Waiver of Liability, Release of Claims, and Agreement to Hold Harmless Defend and Indemnify and the SharpShooters USA Range Safety Rules.
