# From the President

First, I want to thank all of you who attended our Annual Meeting on March 11, 2017. Although there were wintery conditions with snow, low visibility and cold temperatures, we had a great turnout. Once the President Jon Testut got us moving with opening remarks, we had a guest speaker, Judge Moehring, who presented a range of topics which also focused on LBV roads, including associated costs which as expected, are high. In addition, a handout was provided representing tax dollar allocations. Judge Moehring has authorized a Roadway Conditions Assessment study which, when finished within the next couple of months, will rate the condition of all Benton County roads including LBV. With the results in hand our focus will be to develop a comprehensive road work plan for LBV. This will be an ongoing process and updates will be provided as meaningful information materializes. Each of the current Board Members including specialty areas (ACC, Librarian and Air Strip) presented achievements and updates from this past year in all the assigned areas of responsibility. There was a lot of good information provided and everyone did a good job. The meeting was closed out with a Q&A session.

### **Trustee Advisor Election Results**

The election results of the LBV Trustee Advisor open positions were presented and all four open positions were filled. Two were re-elected as their terms had expired and two are new to our Board. This is great news and signifies continued community support.

### Board Meeting following the Annual Meeting

The agenda included Officer and TA assignments to the 14 areas of responsibility. In all cases, each Board Member has new areas of responsibility which will give fresh eyes, new ideas and a refreshed perspective.

### BURNING ON YOUR OWN PROPERTY

If you plan to do yard waste burning on your property you **must** get a burn permit beforehand from Benton County. (If you don't and a fire truck comes out because someone reports smoke at your property, you will be charged for the fire service call.) Call **Benton County at 1-866-207-5140.** Burn Ban info can be found on our website: www.lbvca.com. (Burning of construction materials is prohibited.) *Do not leave smoldering fires unattended!* 

### **CLEANING UP YOUR PROPERTY:**

**Please remember:** Be a good neighbor and rake out leaves and tree debris from your ditches and culverts to prevent water run-off problems, and either burn them or haul them away. *If you hire someone to rake leaves or clear other yard waste from your property be sure to tell them to NOT push it into a ditch or culvert or into the street.* The property owner can bring them to the Village collection site on West Airport or take it to Inland Waste Service (479-878-1384) for disposal. You will be charged a clean-up fee if LBVCA has to clean out your ditch.

**INJURED OR DEAD ANIMALS**: To report an injured or dead animal (deer, raccoon, etc.) and have it removed from a <u>state</u> culvert or <u>state</u> road, contact the **Arkansas Game & Fish Department** at 1-866-253-2506. (They'll need the street address of where the animal is located.) If you find a dead animal or **deer parts** on your property (left behind by illegal hunters), you may bury them but <u>NOT</u> burn them (according to the AR Dept. of Environmental Quality).

The Benton County Roads Dept. and Sheriff's Dept. state they have no program in place for picking up dead deer from county roads or culverts. If the animal is lying in a culvert, notify the AR Dept of Environmental Quality at 1-888-233-0326.

### VILLAGE ROADS:

Green and Blue street signs in the village are county roads. If you live on a road with potholes or ruts, **call Benton County Roads (479-271-1052)** to have it repaired. You do not need to call the Village Office or wait for a Board meeting to report it.

**SPEED LIMIT & PARKING in LBV**: The speed limit throughout the Village is **20 or 25mph** and is enforceable by the Benton County Sheriff's dept. *There is <u>no</u> onstreet parking throughout LBV*.

Remember <u>ONLY TAGGED vehicles are allowed on</u> <u>LBV roads</u>.

**4-wheelers and ATV's** are not allowed on Benton County roads unless they are tagged.

## Roads & Maintenance

### Winter 2016/2017

This has been another mild winter, requiring actual sand/salt/plowing deployment only a couple of times. However, there were several trees and limbs requiring roadway removal. We have been working to decommission winter equipment and preparing tools and equipment for spring. Based on warm temperatures and the mild winter we are expecting a larger amount of roadway clean-up earlier than previous years.

### LBV/Benton County (BC) Roads

We continue to meet and coordinate roadway improvements with BC and have several projects planned and underway. We have also met with Judge Moehring to review our roadway conditions and needs. As most of you have seen by now, BC has installed a guardrail along Slate Gap in addition to numerous traffic signs within LBV all focused on roadway safety. We are coordinating with LBV Water and Sewer for the re-pavement of Pine, which has been approved and funded. There are several culverts planned to be installed in both Posy Mountain and LBV. These will be very helpful in channeling spring water runoff.

**Special Note**: <u>Culverts under driveways and drainage ditches</u> - *The property owner is responsible for making sure that all culverts and drainage ditches on their property are clean of all debris, which includes limbs, leaves, brush etc.* Please make sure that water can flow without obstruction, otherwise there are backups and overflows that require clean -ups. By keeping your property culverts and drainage ditches clear you are helping your neighbors and us to minimize unnecessary money spent on cleanup work.

### LVB Roadway Planning

We are developing a roadway assessment based on usage, safety, and traffic visibility. The objective is to prioritize our roadways and then plan and schedule the equipment and resources necessary to complete an entire roadway or section depending on length. As these schedules are finalized we will communicate via email blitz and ask for volunteers, because the workload exceeds our in-house capabilities. All volunteer help will be greatly appreciated.

BC is conducting a roadway study on all BC roads including LBV. This study is focused upon roadway conditions and is targeted to be completed in the next couple of months. Once both studies are completed we will blend the results together for a comprehensive roadway plan. Next, we will work to develop an implementation plan, which is expected to span several years.

### Road and Maintenance initiative

Although the Brush Collection Facility has been reopened we have purchased a chipper that attaches to and runs off the tractor to minimize burning. This initiative targets environmental reductions with less burning and increased labor productivity. The chipper will be a very useful tool as we begin tree and roadway trimming in the upcoming months. We are in the early stages and will provide future updates.

### Check List

(for approving new construction, add-ons, driveways, fences, decks, etc., in LBV.)

1. Homeowner/Builder contacts the LBV Office (479-359-3204 or office@lbvca.com) to arrange to attend a monthly meeting of the ACC.

2. ACC reviews construction plans, the ACC Building Project Guidelines, and the LBVCA Building Project Check List.

3. If in compliance, the Building Project Check List is completed. An approved/completed LBVCA Building Project Checklist cannot be given to the Homeowner/Builder until all applicable fees and deposits are paid in full.

 The Homeowner/Builder applies to Benton County for a building permit and an inspection schedule.

5. Prior to final inspection and issuance of an occupancy permit, the Homeowner/Builder meets with the ACC member to review compliance with LBV Covenants. If in compliance, the ACC member authorizes a refund of the performance deposit and gives approval for Benton County to perform their final inspection.

Please be aware: Benton County will charge a fee for a building permit and for each inspection. These fees will be the sole responsibility of the Homeowner and/or Builder.
