Compliance dropped significantly in the new year due to MD Charitable Registrations not filed by 12-31-18, along with overdue financial reviews (due 10-31-18) and 990s (11-15-19). Only 36 of our 193 PTAs are now compliant. Please submit these items ASAP.
