◆ LARGE BUSINESS OF THE YEAR (15+ Total Employees)

Large Business of the Year 15+ award is presented by Chamber Ambassadors at our Annual Meeting in February. To be eligible, business must be a current member of the Chamber with **15 or more total employees** (full and part-time). Nominees are reviewed by a committee of Ambassadors, based on the following criteria: Involvement with the Chamber, Community Service, Customer Service, Commitment to Employees, Business Improvement and Growth.

◆ SMALL BUSINESS OF THE YEAR (<15 Total Employees)

Small Business of the Year <15 has the same criteria as above, however, this award is presented to a current member with **less than 15 total employees** (full and part-time). Nominees are reviewed by a committee of Ambassadors, based on the following criteria: Involvement with the Chamber, Community Service, Customer Service, Commitment to Employees, Business Improvement and Growth.

◆ PROJECT OF THE YEAR

We're looking for businesses that have made major, innovative improvements to their facility, including investments in equipment, signage and building structure. Consideration will be given as to how those improvements have improved the overall image of the business district. To be eligible, the business must be a Chamber member, and improvements must be completed by year end.
