Silver Creek Watershed Project Area

- 13.5% of the watershed seeded to native CRP: 2,983 ac
- Conservation Stewardship Program (CSP): 2,423 ac
- Grassed Waterways completed since 2012: 34.8 miles
- Septic System upgrades with IA DNR319 funding: 27 since 2012
- Urban Infiltration practices completed as Soil Health Restoration: 303,987 square ft since 2012
- Ag Waste Systems constructed since 2012: 12

Turkey River Watershed Project Area

- \$7.5 million obligated & implemented conservation
- 26% of cropland in watershed seeded to nearly 13,000 ac cover crops
- Shallow Wetland creations: 14
- Streambank Stabilization constructed: 7,500 ft
- Beginning the process on 8 new WQI Wetland sites
- Beginning the process on 14 new Edge of Field sites

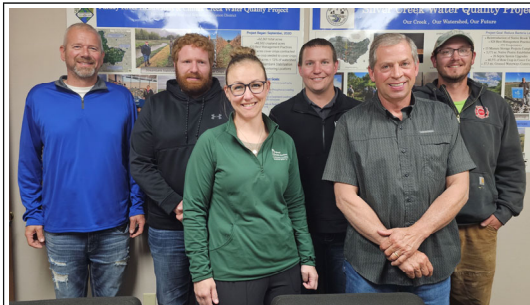
