### ATTENDING VETERINARIAN AND ADEQUATE VETERINARY CARE (DEALERS AND EXHIBITORS).

\*\*\*A male Cavalier King Charles Spaniel (#026-285-517) had a raised swelling approximately 1/2 inch in diameter between the middle toes on the right front foot. The area appears red and swollen. Some of the surrounding fur appears wet. The licensee had not noticed this dog's condition until the inspector pointed it out. This raised, abnormal swelling between the toes could be the result of injury, infection or a variety of veterinary medical conditions which may be painful. The licensee must consult with a licensed veterinarian in order to ensure that an accurate diagnosis is obtained and an appropriate treatment plan is developed and followed. The licensee must ensure that all animals receive adequate veterinary care at all times. Note: the licensee contacted his veterinarian for an appointment for this dog during the inspection. The veterinarian did an examination of the dog and a treatment plan was developed after the facility inspection was conducted. The licensee must ensure that the treatment plan is followed.
