President's Message

WHEN you build it....

It's time to build the new Cabana. At the last meeting, the board approved the recommendation of the Cabana Committee and selected a contractor for the new Cabana.

Now we figure out the best way to pay for it. We've gone ahead and explored our options and now are going to ask your opinion. If you are on NextDoor, you will see a survey just for Fiesta Gardens owners, on the options for paying for the Cabana and the necessary information you need to give us your opinion. (If you're not on NextDoor and want to participate in the survey, please email treasurer@fiestagardenshoa.com and we'll email you a link).

Some of my thoughts on the subject...

- 1. If we choose to do a one-time assessment with no dues increase, we save on interest, and we pay for the whole thing now by those who live here now. Your property value goes up. And we have a nice new Cabana!
- 2. If we choose to do a small assessment along with a dues increase, we pay interest, and we pay over a 20-25 year period, with everyone that lives here over that time period paying their share. Your property value goes up. And we have a nice new Cabana!

Also, very soon, you will have access to an artist's rendering of the new Cabana, as well as a floor plan. You'll be able to see a picture of what we're buying. I've seen the plans. You're going to be impressed. The Cabana Committee has spent the last four-plus years getting us to this point and are to be commended. It hasn't been an easy road, and it took longer than we had hoped, but we're so close you can almost smell the paint. Thanks again.

After we get the survey results, when we DO get to the actual approval process, the most important thing will be that EVERYBODY VOTES. The VOTE will be the VOTE, and no one will tell you *how* to VOTE (they *may* ask), but please just VOTE. To make these kinds of decisions, we not only need a majority, we need a quorum. What that means is that a certain percentage of the membership has to VOTE. (Seeing a theme here??) Unfortunately, the voting process we must follow can get expensive, so we only want to do this once.

Cabana financing options

- o Mortgage 100% of project through dues increase.
- o Mortgage 50% of project through dues increase plus one-time assessment.
- Waiting for actual cost numbers to be determined before decision put to membership. Survey to be done in advance of vote to gauge preference of membership.

Hello Neighbors!

San Mateo's height, density and affordable housing protections are at risk!

Wondering why your November ballot didn't have a measure to continue these protections?



Do you remember being asked to sign a petition last spring to renew San Mateo's height, density and affordable housing protections by placing the "extension of Measure P" on the ballot? Over 7,000 San Mateo residents signed that petition, far exceeding the number needed.

Despite the support of so many San Mateo voters, our City Council chose not to place the measure on the 2018 ballot. Fortunately, our signatures are still valid for the next regular election, November 2020. The City Council has a minimum legal duty to put the measure on that ballot, but even that is not assured.

Attorneys for well-financed development interests, including Hillsdale Mall's Bohannon Development Co., have been actively trying to prevent our measure from ever reaching voters. They claim the measure, San Mateo policy for 25 years, is "flawed", and have even encouraged costly lawsuits to silence citizen action. This is a classic big-money tactic to thwart citizens' grassroots efforts and keep you from voting on this important issue.

We believe that residents directly affected by city-wide land-use decisions should have some control of those decisions, not just three council members on any given Monday night.


Social Director's Report
