

Pool Operations

The pool hours will be changing starting Wednesday, August 10th. The pool hours will be 4:30 PM to 8:00 PM, Monday thru Friday; Saturday and Sunday from 12:00 noon until 8:00 PM. Adult swim will be Saturday and Sunday from 11:00 AM to 12:00 noon. These hours will remain until pool closing which will be Sunday, October 16th.

Monday, September 5th, Labor Day, the pool will be open from 12:00 noon until 8:00 PM.

There might be some temporary and unscheduled closures of the pool due to the construction of the new cabana as we get closer to completion.

Remember, parents and those responsible, to watch your kids in the pools, whether they are in the big pool or the small pool, whether they are good swimmers or not. Drowning is the leading cause of death for children ages 1 to 4 years old. For ages 1 to 14 years old drowning is the second leading cause of unintentional injury death after motor vehicle crashes.

If you have noticed, all of the umbrellas have been removed from the tables. The reason for this is the wind. 3 of the 7 umbrellas broke in 1 week. With the removal of the old cabana, the wind that travels through the pool area and the pool deck is much stronger than what it used to be. The current style of umbrellas do not withstand the current wind conditions. We are looking at different options and umbrella styles.

May 4th Minutes –On a motion duly made and seconded and approved by all Board Members, the May 4th minutes were approved.

Civic Report

Bermuda Bridge Project

The bridge on Bermuda Drive that crosses Borel Creek needs to be replaced. The city is in the planning stages of how to do this and are asking for feedback from Fiesta Gardens' residents. The city could make plans to present two options:

1. **Option 1.** Demolition and construction would occur in two phases. Phase I would see the demolition and reconstruction of the west side of the bridge first. During this phase the east side would remain open for traffic and signals used as this would be single lane only. In phase II the newly constructed east side would be open (enough room for 2 lanes) as the east side is demolished and reconstructed. This option would take about 18 months and involve two rounds of demolition and construction (including driving the piles). It will take this long as local ordinances require work can only be conducted from April through October (dry season) each year.
2. **Option 2.** The entire bridge would be demolished and constructed in one phase. A temporary pedestrian bridge would be made to cross Borel Creek. Vehicle access would be facilitated by demolition of the sound wall either at Bermuda Drive and Saratoga or Annapolis and Saratoga. This would be temporary and the wall replaced after project completion. This option would take ~13 months with one round of demolition/construction/pile driving.



The city engineers are aware that historically there has been significant negative feedback on opening up Fiesta Gardens to Saratoga and asked me to gauge the current sentiment of residents. If there is still general opposition to Option 2, they will not even consider it. *Please let me know your opinion on this ASAP.* I will communicate the quorum opinion to the city engineers.

This project is planned to start in 2025, there are still a ton of details to sort out, as well as outreach to those residents who live close to the bridge. This will happen over the coming months, and I will keep everyone informed as to progress.

Council elections 2022

For those of you who don't already know, the city of San Mateo has moved to district elections. San Mateo was divided into 5 districts (<https://www.cityofsanmateo.org/4537/District-Elections>). Current distribution of council members is:

- o District 1: Rick Bonilla, Diane Papan, and Eric Rodriguez
- o District 2: Amourance Lee
- o District 3: Joe Goethals
- o District 4: No sitting Council Member since transition to district elections
- o District 5: No sitting Council Member since transition to district elections

Fiesta Gardens is in District 3 (along with Central, Sunnybrae, the Village and Laurie Meadows). Currently, Joe Goethals is our grandfathered-in representative, but he is not running for re-election.

I am waiting to find out who plans to run in November for District 3 and I plan to get as much information and invite them to attend a Board meeting to answer questions from you all. To date the only candidate I have heard from is Rob Newsom. More to follow on this.

Fiesta Gardens Back to School Pool Party

Celebrate your kids going back to school with games, prizes, food, and good company.

When: Friday, August 12

Time: 4:30 pm - 7:00 pm.

Where: Fiesta Gardens Pool

Food: Grillzillas Truck (Burgers, fries and Salads) Pay via credit card or cash

Dessert: Ice cream: FREE + bring a dessert to share if you want to!

Game line up: (unless noted, games are for all and will be divided by age and prizes will be given to the younger and older groups)

4:30 pm – SeaHorse Relay - Using a pool noodle, players will be divided into teams, one on each side of the pool. On the go, the first player jumps on their "seahorse" and swims to tag a teammate on the opposite side of the pool. The next player jumps on the sea horse to tag the next teammate. Repeat until all teammates have gone. Fastest team wins!

5:00 pm – Sponge Relay: Put a bucket full of water at the start line and an empty bowl at the finish line. The goal is to fill the bowl at the finish line with water carried in the sponge before the music ends.

5:30 pm – Duck Push: Each player has a rubber duck and must push it to the other end of the pool without using their hands! They can push the ducks with their noses, blow on them, bump with their foreheads or splash the duck - whatever to get it moving. First one to the end of the pool wins.

6:00 pm- Ball Squirt - Relay race using a squirt gun - players are set in teams and each player will send their ball across the pool to the other side where their teammate will send it back. The first one to get to back wins.

6:30 pm - Pick up sticks Relay/Numbers crunch - Glow sticks and ping pong balls with points written on them will be thrown in the shallow end for the little ones and the deep end for the older, stronger swimmers. Players will be divided into teams and on the go, one player from each team gets a glow stick or ball and then tags the next teammate. When all sticks are retrieved, the team with the most points wins.

7:00 - Bellyflop contest! **Strong swimmers only.** Judges needed!




