Attire All handlers, judges, workers, and gallery members must be attired in an article of blaze orange while on the ACBD Club grounds.	Address :
Birds Quail, Chukars, Pheasant, and/or Pigeons will be released for all test levels. Ducks may be used in the Water Test.	Test(s) Registering :
Handlers Handlers are expected to fire a blank pistol at the appropriate time during the testing of their dog. Pistols used must be incapable of firing live rounds. The GSPCI is not responsible for providing blank pistols.	AGREEMENT I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered above.
