ORDINANCE No 7/ O

An Ordinance, providing for the lesuance of internal improvement Bonds of the Gity of Garnett, Kansas, to pay for the paving, curbing and guttering of certain portions of certain streets and avenues in said city.

WHEREAS, in persuance of proceedings duly had and taken according to law, by the Board of Commissioners of the City of Garnett, Kansas, contracts have been let for for the paving, curbing and guttering of main Street from the North line of Fourth Avenue to the North line of Seventh Avenue in said City.

Whereas all legal requirements have been fully complied with to authorize the issuance of bonds of said city on account of said improvements: therefore

Be it ordained by the board of commissioners of the city of Jarnett, Mansas:

between the limits hereinbefore stated, there shall be issued a series of Bonds of said city of Garnett in the aggregate amount of \$9387.50 which shall consist of 9 bonds of \$1000.00 each, and one Bong of \$287.50 before at of September 1, 1917, numbered from One to Ten inclusive at the rate of Four and Three Fourths per cent per annum, payable semi-annually on March and September 1st. of each year and shall become due and payable as follows:
