The Amana News and Notes reporter wishes to acknowledge an incorrect statement in the previous week's ASI Bulletin regarding the recent garage fire at 27 220th Trail, Upper South Amana. This property is owned by Linda Gipple. This reporter is sorry if the mis-statement caused any confusion.

Old Creamery Lives On

The Old Creamery Theatre Company, the oldest professional theatre company in Iowa, sadly shuttered its doors permanently in February 2022 when its board of directors announced that the staff had been terminated and the theater closed.

Remaining was a group of dedicated company members, former employees and volunteers scattered across the country and over 40 boxes of OCTC photographs, slides, programs, original scripts, posters, board minutes, rehearsal notes and records.

Tom Johnson and Meg Merckens, Middle Amana, are stewards of this treasure trove and hope to sort, inventory and find a home for the OCTC archive.

This week they will take a large step toward that goal while gathering former OCTC company members and volunteers from all over the United State to Amana.

"We'll have about 25 Old Creamery friends, actors, company members, board members and family here Monday Sept. 22 through Sunday, Sept 28," explained Tom Johnson who noted that the Amana Arts Guild has graciously opened their High Amana Folklife Center to the volunteers and the material.

"We'll be working in groups, two sessions every day, more on the weekend of course, going through these boxes, sorting out what needs to be kept, what needs digitizing and what we have duplicates of," he explained. In the evenings they'll be sharing meals and socializing. They'll be at the AAG Center from 10 am – 1 pm and 2 – 5 pm, Monday September 22 through Saturday, September 27.

Making digital copies of the photographs and the videos (3 large boxes of videos) will be a primary goal. To do that they've purchased and have borrowed equipment to digitize as much as possible.

"It will be too much to do in one week, but we want to make a real start and get it all sorted out," Johnson added.

They will also document what they are doing to create a short 8 to 10-minute video presentation to show institutions and potential donors what the material is and what the Old Creamery has meant to people all these years.

It will be a labor of love, but it's also a necessity, as much of what's being saved is in a form that has a very limited shelf life. Plus, as Johnson explained, it's time to find a permanent home for the material.

Looking for a home for the OCTC archive is important. It will take cash, in addition to the help of many volunteers, to preserve the archive. That includes hiring a professional archivist to catalog and work with the materials so that they can be given to an institution.

Nothing can recapture the songs, the laughter, the tears of the one and only Old Creamery, but we can preserve the memories.

When Hank Bendorf recovered that shoe box on the picnic table in front of the old clubhouse which contained the proceeds from the first ever Oktoberfest, he could not have known what he was saving. For as he said in 2015, "I can tell you that if someone had found that shoebox and taken the money we wouldn't have had another Oktoberfest. That would have been it."

As it was, the successful 1962 fest which attracted a few hundred people made a nice donation to the summer recreation program for Amana kids and the Jaycee's began planning for 1963. The next year

more volunteers pitched in and created a longer show. The “PR” committee enlisted a group of Amana High School kids to walk around the Saturday University of Iowa Football game parking areas sticking fliers under windshield wipers advertising Amana’s Oktoberfest the next weekend. It worked and the festival took off, tripling in size.

The next year the “stage show” moved to the Lakeside Elementary School Auditorium. It grew to a 2-hour- long, uniquely Amana creation that was part Lawrence Welk variety show and part Bavarian opera/fantasy. It included love ballads, dance numbers, solos, duets, small groups, a women’s quartet, a men’s choir, kids’ numbers, comedy bits, an audience sing-along and a whole lot of German schtick. People ate it up with a spoon.

But that didn’t mean it wasn’t hard, hard work. Virginia Nordyke, the Middle Amana Postmistress, managed the box office. The seats were marked in the Amana gym and sold as “reserved” or bleacher. The dedicated Nordyke took every reservation by phone or mail and mailed out all of the tickets. The will - call office took four volunteers to run on show nights. The Y-Teens were enlisted to serve as ushers. They used all the folding chairs the school had, rented 300 more and brought in bleachers from the Marengo Fairgrounds. They could seat 1,450 people at each show Reynold Messier confirmed. They gave three shows and usually sold out both the Friday and the Saturday night shows. Reserved seats were \$1.50.

Amana artists Ray Berger, Rozella Hahn, Gordon Kellenberger, Mary Jack and Mary Wendler painted scenery on thick cardboard boxes from the Amana Refrigeration. It depicted an alpine Bavarian village. This backdrop eventually was stored in the Fest halle and used for 25 years of Tannenbaum Forests plus its annual appearances at Oktoberfest. (Dusty and looking its age, the scenery was finally laid to rest just four

years ago.)

For the stage show, the cast members borrowed, sewed or mail ordered dirndls from Germany Few men had actual Lederhosen so some of the men had brown corduroy or woolen breeches sewn. Those cast members that had an original German costume were kept on stage to dress up the sets during numbers and “bits.” They stood about decoratively or were seated at tables in and around the “village” sipping beer or wine from mugs and glasses. A master of ceremonies kept the show moving and told a few jokes. George Trimpe, Benny Bendorf, Glenn Wendler and Fred Hahn each did the honors over the years. All of them had the help of Dr. Henry Ruff, who also made sure everyone’s German was up to snuff. His wife, Inge, had a lovely voice, as did many of the participants and no one could beat the accordion playing of Lillian Zierold, Emily Oehl and Anne Leonhardt.

Musician Bob Zuber created nearly all the arrangements for the show and helped get the band together. Stage show cast rehearsals started mid winter and went all spring till mid summer when twice weekly and even thrice weekly rehearsals became necessary. Elementary music teacher Rita Wilson and show founder, Emmaline Bendorf, both wonderful musicians, worked with every group and solo vocalist. The rehearsals took place at the Homestead Welfare Clubhouse and included plenty of time for socializing. “We really had a lot of fun,” Gerda Graesser told me in 2008.

In 1967 the Amana Oktoberfest was listed as a “TOP 20 US Travel Event” the National Association of Travel Organizations and bus companies took note.

By then it was at the Middle Amana “ball park.” That was the only space big enough - but the park had no electricity, no paved areas, no covered pavilion and certainly no Morton Building. All of that would come later and would be paid for by the festival itself. More about that next week as the story continues.

Wintering in Texas, Marilyn volunteered at ice hockey games, was a Salvation Army bell ringer, helped with Boarderfest and decorated the park hall for all holidays. Marilyn is survived by her daughter, Pam Lockhart of Cedar Rapids, two grandsons, Kyle (Haley) Lockhart and their children Reese and Jensen, and Shane (Lizzy) Lockhart and their children Wyatt and Watson; her daughter Cheri (Jim) Kirk of Cedar Rapids, and grandchildren, Amanda (Chad) Smes-tad, Heather Flynn, Jess Thomson, and David Kirk along with their families; brother, Don Blessing; sister, Marleen (Barry) Hedges; and sister-in-law, Lori Blessing.

She was preceded in death by her parents, husband, Richard, son-in-law, Robert Lockhart, brother, Dick and his wife Jean Blessing, and her beloved dog, Molly.
