Disaster claim #4343 the total is \$137,246.70 has been approved and we have filed to use on an alternate project. No determination has been made yet. Dan gave an update on the information he received on Wisconsin Emergency Management property buyout program.

We discussed the County 911 and Fire EMS resolution. A motion was made and seconded to adopt the resolution. The motion carried.
