WINTER TAX INFO & Reminders.....

IMPORTANT 2016 DATES TO REMEMBER:

- February 16—ALL TAXES ARE DUE without penalty, including deferred summer tax.
- **February 17—**Taxes are PAST DUE and a 3% penalty will be added.
- February 29—LAST DAY TO PAY TOWNSHIP TREASURER.
- MARCH 1st—PAYMENTS FOR REAL PROPERTY TAXES MUST BE PAID TO THE COUNTY TREASURER. Please call 989-224-5280 for payment information.
- FIRSTMERIT BANK will be accepting WINTER tax payments NOW through February 16, 2016. You can make your tax payment at the Main Office located at 200 West Higham Street, St. Johns—Monday-Friday 9am-5pm. Please bring your entire tax bill and payment in full. They will stamp your portion of the tax bill as paid and this, along with your cancelled check, will be your receipt. NOTE: Summer Tax payments CANNOT be made at the bank, due to interest calculations.
- POSTMARKS ARE accepted as long as we receive your payment within 5 days of mail
 date, and the postmark is clear and legible. If it is missing or not legible, you may be billed for
 interest and/or a penalty.
- We DO accept PARTIAL PAYMENTS. These must be paid to the Township Treasurer. Either mail
 in your payment, or pay in person. After your payment is posted, I will send you a revised bill
 showing your payment and new balance
- NEED A RECEIPT? If you would like a receipt and you are paying by mail—Please send your entire tax bill with a SELF-ADDRESSED, STAMPED ENVELOPE (SASE) and your receipt will be mailed to you. IF Pq`AYING IN PERSON: Please bring your entire tax bill with you. We will stamp your portion of the bill as paid—this will be your receipt.

 This saves the township hundreds of dollars and we appreciate your consideration with this!
- Delinquent Personal Property Tax is paid to Township Treasurer. Please call 989-224-2150 for payment information. A note to anyone changing the name of their company or selling to a new owner—Personal Property (and the tax) follows the Personal Property and the new owner is liable for any unpaid tax.
- I will be collecting taxes in my home (address is on your tax bill) on the following dates, or you
 may call for an appointment:

Wednesday, December 30, 2015 9am-5pm
Wednesday, January 27, 2016 10am-4pm
Tuesday, February 16, 2016 10am-4pm
Monday, February 29, 2016 9am-5pm

- Drop Box is always available (North side of house). Please leave your payment in an envelope, if possible. If you'd like a receipt, please leave a note and/or your entire tax bill along with a stamped envelope and a receipt will be mailed to you.
- DEFERRED SUMMER TAXES ARE DUE FEBRUARY 16, 2016.
- Anyone with Summer 2015 Taxes still owing—You should receive a separate bill showing the current payoff amounts—please call if you haven't received one.
- Michigan Disabled Veterans may be eligible for exemption of the property taxes on their principle residence if certain qualifications are met. If you think you might be eligible, please contact our Assessor, Beth Botke for information. REMINDER: This exemption is granted on an ANNUAL basis. It must be renewed each year.

Medication Disposal Programs

Protect your family, pets, the community and the environment by properly disposing of unwanted or expired medications through one of the programs noted below. Do not put medications "down the drain" or in the trash. They can end up in surface waters and negatively impact local ecosystems. The preferred disposal option is through special events which ensure safe disposal thru incineration.

PLEASE KEEP YOUR MEDICATIONS IN THEIR ORIGINAL CONTAINERS, BUT BE SURE TO BLACK OUT ANY PERSONAL INFORMATION. THIS IS REQUESTED AT ALL SITES. Please do NOT bring needles, EPI pens, inhalers, aerosols or patches—These items can ONLY be handled at the ANNUAL CLEAN COMMUNITY EVENTS.

The Sparrow Clinton Memorial Pharmacy can accept all non-controlled pills, tablets and liquids year round, free of charge. Please call them for additional information and hours at (989) 224-8155. Controlled medications, such as narcotics and behavioral medications can be safely and securely dropped off at the Clinton County Sheriff's Office lobby Monday through Friday 8:00am to 5:00pm.
