TOWN OF STRATTON VERMONT STRATTON SCHOOL BOARD TUESDAY, May 7, 2019 STRATTON TOWN HALL

The Stratton School Board met as warned on Tuesday, May 7, 2019. The meeting was called to order at 7:00pm. No modification to the agenda – The board immediately recessed to enter into the Special School District Meeting warned for 7:00pm, May 7, 2019 at the Stratton Town Hall. Please refer to the Minutes of the Special School District Meeting for results of that phase of the scheduled agenda. Please refer to the Voter Checklist recorded for that meeting for a list of resident attendees – minutes of said include non-resident guests in attendance.

The Special School District Meeting adjourned at 8:00pm. Immediately following the meeting, the School Board Meeting reconvened and Lorraine Weeks-Newell read the Notice for the Public Hearing to consider the adoption of a revision to the Tuition Payment Policy Code F16. Of the two options under consideration, as stated in the Notice, Policy "Option A" was the version which complemented the budget adopted at the preceding Special School District Meeting. This option offered a revised Section 3C as follows:

Tuition shall only be paid to receiving schools that enroll students deemed to be residents of the District, in accordance with a student's Individualized Education Program Team decisions, when applicable. No tuition payment shall be made to any school that discriminates based on special education eligibility, a student impairment or disability or race, religion, ethnicity, national origin, sexual orientation, gender identity, gender or other protected characteristic.

Tom Montemagni moved to adopt said option. Allison Young seconded. All concurred.

At this time, the School Board recessed the meeting and moved to the Town Office, as per the agenda.
