# A Message from the Chairman of the Board of Trustees

This is a revision to the e-mail I sent out on May 9 regarding the participation rate of 13.8% in the 2020 Census for the Village of Innsbrook. This past Tuesday during the regular monthly meeting of the Board of Trustees for the Village of Innsbrook, on ZOOM because of COVID 19, I was advised by Chad Eggen, Executive Director of Boonslick Regional Planning Commission, that he had been in touch with an official with the Census Bureau and learned that the 13.8% participation figure was NOT accurate. So disregard that 13.8% participation figure.


I participated as an on the ground worker in the 2010 Census, and my task was to record for a map with the Census Bureau in Washington D.C. for my assigned territory of Warren County every plot of land that had on it a structure that either did have persons residing in it or could have persons residing in it. At the time the Innsbrook Resort had about 1,000 chalets that I knew, with one or two exceptions were not permanent residences for anyone, and had some homes that were secondary homes for the owners and not their permanent residence. I reported these facts to my supervisors with the Census Bureau, as I did not think these structures should be counted in the 2010 Census, but I was instructed to count them all for the Census Bureau map.

Therein lies the problem we have now. The 13.8% participation figure for the Village of Innsbrook includes what are now over 1,200 chalets and secondary homes. If the chalets and secondary homes are extrapolated out of the equation the participation figure for the Village of Innsbrook for the 2020 Census is really much, much higher. I understand that the Census Bureau is now working to correct this inaccurate calculation.

So my revision message to you is twofold. First, you are receiving this newsletter because you have previously agreed to be a part of the Village of Innsbrook e-mail address list, BUT my revision message only applies to those of you who are permanent residents of the Village of Innsbrook and have not yet responded to the 2020 Census inquiry. We do not have a method to single you out of our e-mail address list. The rest of you please ignore this revision message as it is not intended to apply to you. Second, if you are a permanent resident of the Village of Innsbrook and you have NOT previously responded to any of the several 2020 Census inquiries I do urge you to please go to the internet website my2020census.gov and give your response.


