HARRIS COUNTY EMERGENCY SERVICES DISTRICT NO. 29

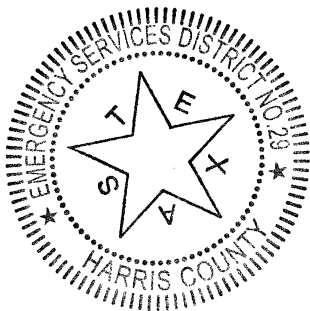

The District will consider and act upon the following matters:

1. Call meeting to order.
2. To receive public comment.
3. To receive a report from Brad Dill of BD Realty and take with respect to any MMG pay applications.
4. To review and take action on reports and construction matters from District architect Ricardo Martinez of Martinez Architects for the Station 12 construction project.
5. To review and take action of any pay applications submitted by JE Dunn and approved by Martinez Architects.
6. To approve the Minutes of prior meeting(s).
7. To receive a report from the District Bookkeeper, to review and take action on the Treasurer's Report.
8. To pay, authorize or ratify District bills and authorize fund transfers required to for operations and capital expenses.
