Motion Trustee Bendix, seconded Trustee Blodgett and carried unanimously to accept the low bid from Kenyon Pipeline to televise and map 7000 linear feet of the 8"-10" sanitary sewer main on South Main St. at a cost not to exceed \$9,250.00. This is part of the Route 88 reconstruction project.

Mayor Taylor noted the following:

- The Village had a meeting with representatives for DSS, the subcontractor for the NYSEG natural gas line replacement project in the Village of Newark. DSS is going to finish repairing streets, sidewalks and lawns that were disturbed in the process last year. They are behind because of the bad weather.
- Mayor Taylor also noted that NYSEG has acknowledged receipt of the letter from the Village of Newark requesting that they provide us with a buy back price for the street lighting fixtures in the Village that NYSEG currently owns. They have 90 days to provide the proposed purchase price. The Village will then negotiate with them, if necessary, before final purchase as part of the LED Street Lighting upgrade project.
- He also noted that the Board should have received the flyer that contains the information for the Memorial Day celebration for Newark. The Mayor also shared the start time and major points.
- LEGAL Mr. Williams had nothing for open session.

The Chief noted the following:
